WATER

One older windmill and one electric submersible well provide water to various water troughs on the ranch. Three ponds throughout the property also provide a great water source for livestock and wildlife. The largest of the ponds has been known to hold water well even during drought times and is stocked with catfish and bass.

VEGETATION AND TERRAIN

Gently rolling terrain promotes a variety of vegetation changes from hardwood bottoms to lush hilltops and everything in between. Strategic brush clearing and management has opened up lush fields of coastal bermuda great for grazing or hay production. Native brush species include but are not limited to live oaks, hackberries, elms, mesquite and guayacan.

WILDLIFE

An abundance of wildlife call the area home including whitetail, turkeys, feral hogs, varmints along with native and migratory birds. One of the greatest benefits this property has to offer is that it has not been hunted in several years, making wildlife plentiful.
