### **EXECUTIVE SUMMARY**

The 101 Club

The 101 Club is a secluded, private, gated sporting retreat offering excellent hunting and lodging with annual income-producing farmland. The property consists of 206.0 +/- contiguous acres, which is professionally developed to provide the sportsman a turn-key outing place foremost for duck hunting; however, dove and deer hunting opportunities are also available.

The property is located in Cross County, just west of Hickory Ridge, Arkansas. The land is easily accessed via Highway 42 and off County Road 101. The property is a quick 30-minute drive from Jonesboro, Arkansas, and Memphis is only 75 miles away. The land is positioned in the heart of Northeast Arkansas duck hunting country and has an excellent duck hunting history. The property rests on Bayou DeView, a legendary waterfowl flyway, and is only five miles east of the Cache River. Many renowned and productive duck hunting properties adjoin or are within proximity to the land.

The acreage is well-designed for duck hunting with large, planted waterfowl food plots and strategically placed blinds. There are two duck blinds, one which is built into a permanent levee and the other is positioned into a tree line overlooking a food plot. However, there are several locations where two or more large, comfortable duck blinds can be built. Hunting is also done along the various tree lines throughout the property.

The current owners have invested in many improvements to make the land efficient for agriculture and recreational use. In 2017 six miles of three-phase power were installed to support two new electric wells for irrigation and water for duck hunting. The internal road system has been revised and updated, the levee on Bayou DeView has been rebuilt, and water control structures have been installed for regulating seasonal water depth for duck hunting.


A new 2,500 square-foot lodge was constructed in 2017 with all necessary utilities on gated spacious grounds. The lodge is fully furnished with particular attention to details and amenities. The structure offers five bedrooms and four baths, spacious nine-foot ceilings throughout, a den and wood-burning fireplace, a full bar, a custom kitchen with stainless steel appliances, a mudroom, and a large exterior covered deck overlooking the property. The lodge has an excellent, separate heated and cooled secure facility, which serves as a gun room with lockers, gear storage, gun safe, and storage for tools, supplies, ATVs, boat storage, and more.


### **LOCATION - REGIONAL VIEW**

Lodge Parking Area




### Exterior Equipment Storage Facility



Located just steps outside the main lodge is a 8' wide x 40' long x 8.5' tall (320 square-feet) steel shipping container, which has been converted into an excellent secure storage facility. 15' of the container serves as a heated and cooled gun room with lockers, gear storage, and a gun safe. The remaining 25' provides a secure storage room for tools, supplies, ATVs, boat storage, and more.




