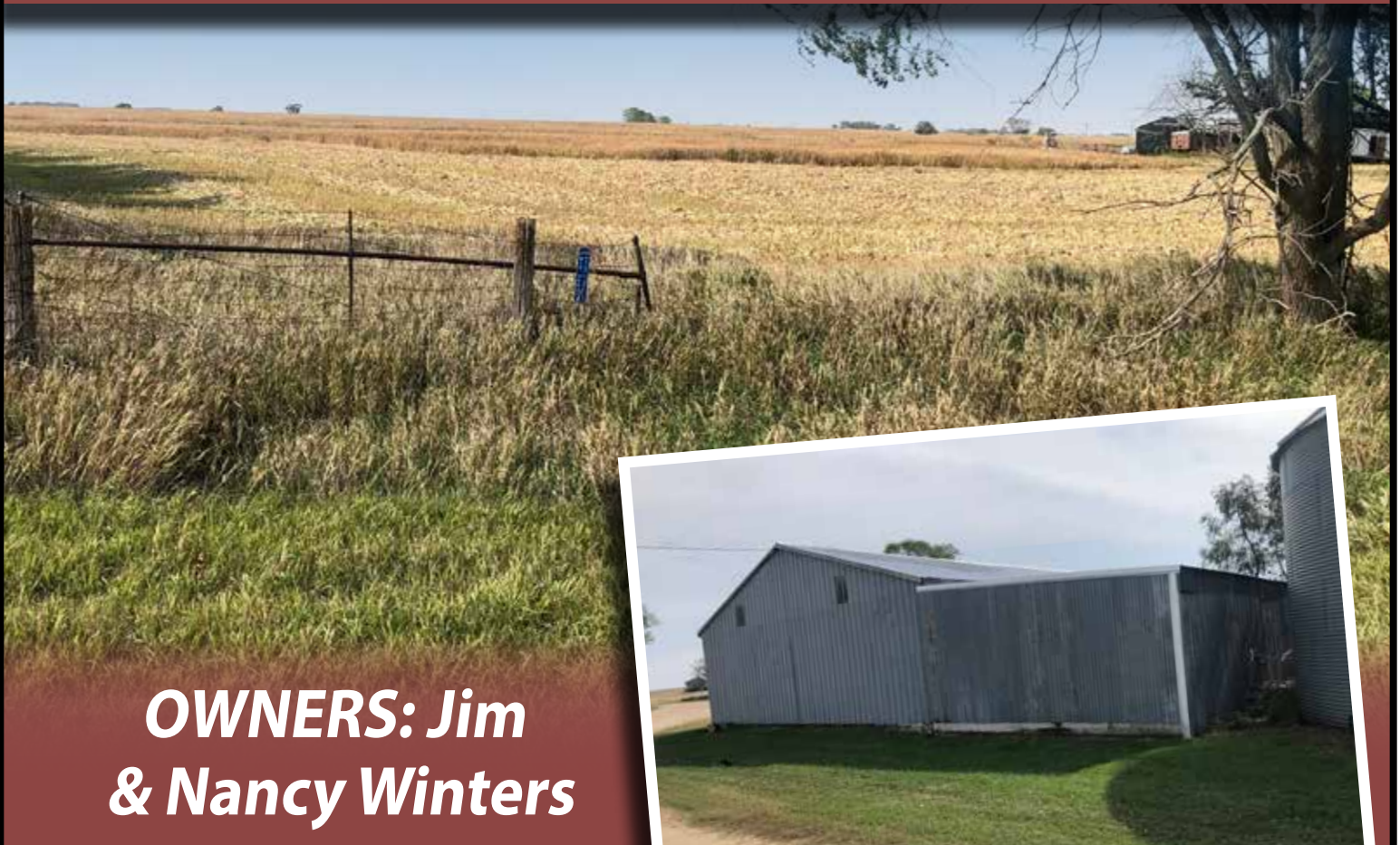

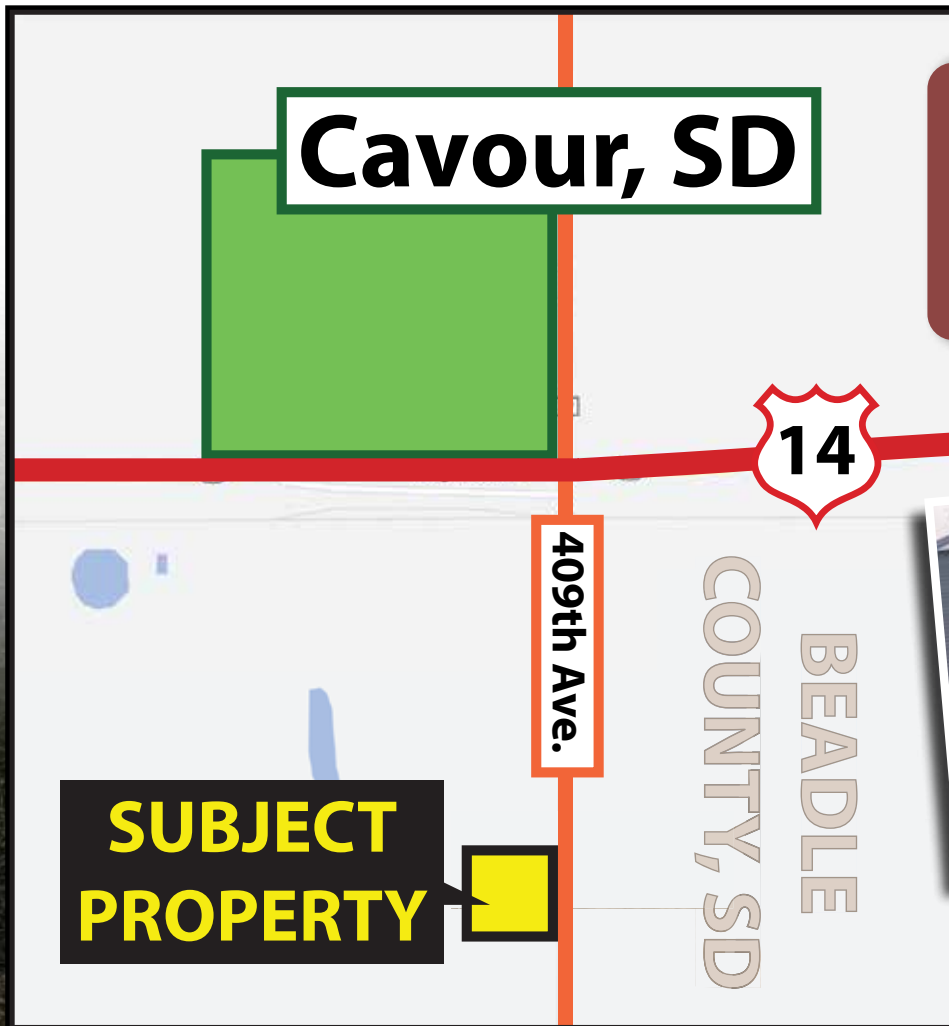

General Information

AUCTION NOTE: This 13 +/- acre building site features a 70' x 80' shop with 20' x 80' addition on the west side of shop. Shop and addition have concrete floors. The shop has 12' exterior walls, one walk in door, 18' south machinery door and 14' east machinery door. Both machinery doors are on sliding rails. The main shop area has single-phase 110/220 power. (3) 5,500 +/- bushel grain bins. Mid Dakota Water runs adjacent to the property along 409th Ave. 409th Ave. is a nice, paved county road running directly south of Cavour, 10 miles from Huron, SD. This property holds a unique opportunity for a buyer to own a nice shop and an enclosed storage area with concrete floors. Small amount of farm ground and commodity storage.

Terms & Conditions

I. Terms and Conditions of Auction

The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area
