Field notes for a tract of land containing 10.12 acres, called Tract 20, lying in the J. Poinevent Survey No. 8, Abstract No. 1196, Atascosa County, Texas, as shown on the accompanying Plat of Survey, prepared for Michael Schwarze, dated January 30, 2021.

Field notes for a tract of land containing 10.12 acres, called Tract 20, being out of a 346.05 acre tract of land, lying in the J. Poinevent Survey No. 8, Abstract No. 1196, Atascosa County, Texas, described in an instrument, recorded in Clerk's File No. 210102 of the Official Public Records of Atascosa County, Texas, said tract of land being more particularly described by metes and bounds as follows:

Beginning at a point, marked by a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering and Surveying, set on the East line of said 346.05 acre tract of land, lying in County Road 332, and being the Northeast corner of a 10.16 acre tract of land, called Tract 21, surveyed this same day, which bears North 14° 45' 29" West, 269.00 feet, from a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering and Surveying, found previously set for the Southeast corner of said 346.05 acre tract of land, at the Northeast corner of a 178.00 acre tract of land, described in an instrument, recorded in Clerk's File No. 116858 of the Official Public Records of Atascosa County, Texas, said point of beginning being the Southeast corner of this tract of land;

Thence South 75° 42' 16" West, 1543.13 feet, across the said 346.05 acre tract of land, being the North line of said Tract 21, to a point marked by a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering & Surveying, set for the Northwest corner of said Tract 21, and lying on the East line of a 10.01 acre tract of land, called Tract 22, surveyed this same day, said point being the Southwest corner of this tract of land;

Thence North 14° 45' 29" West, 297.27 feet, across the said 346.05 acre tract of land, being he East line of said Tract 22, and continuing along the East line of a 10.09 acre tract of land, called Tract 23, surveyed the same day, to a point marked by a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering and Surveying, set for the Southwest corner of a 10.11 acre tract of land, called Tract 19, surveyed this same day, said point being the Northwest corner of this tract of land;

Thence across said 346.05 acre tract of land, along the North line of said Tract 19, the following bearings and distances;

North 76° 24' 49" East, 1139.35 feet, to a point marked by a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering and Surveying, set for an angle point of said Tract 19, said point being an angle point of this tract of land;

North 78° 33' 08" East, 404.65 feet, to a point marked by a 5/8 inch steel rod monument, with cap stamped Rakowitz Engineering and Surveying, set on the East line of said 346.05 acre tract of land, for the Southeast corner of said Tract 19, and lying in County Road 332, said point being the Northeast corner of this tract of land;

Thence South 14° 45' 29" East, 263.07 feet, along the East line of said 346.05 acre tract of land, and across County Road 332, to the point of beginning;

The basis of bearing for this survey is Grid North, Texas State Plane Coordinate System, NAD 83 (2011), South Central Zone.
