The Hughes Pasture is located in southern Banner County, Nebraska just four miles west of HWY 71. Comprised of 644 deeded acres, the subject property has 22.12 acres enrolled in CRP with the balance being in grass. There was an additional 133 acres enrolled in CRP that came out this fall and has not been grazed. The pasture is watered via a submersible well & a



windmill. Improvements on the property include a remodeled 2 bed, 1 bath home, garage, shop, corrals, and a lean-to made out of stacked storage containers. County Road 6 runs along the north boundary of the property and provides easy access off HWY 71.













