Dear Landowner:

Magellan Pipeline Company, L.P. will be developing and constructing a pipeline project in Bell County, Texas, which may cross lands owned by you in such county, or in which you may have an interest. One of the first activities that will be undertaken will be to seek permission from you to survey across your property.

By this letter, Magellan Pipeline Company, L.P. respectfully requests permission to survey a proposed pipeline route across your property. Enclosed for your review and signature is a Survey Permission form. Please note any special instructions that the survey crew needs to be aware of as they conduct the survey in the space indicated on the form. Please sign the Survey Permission form and return the form by mail in the stamped, self-addressed envelope included for your convenience.

In addition, an Agent representing the pipeline project will be contacting you shortly to discuss the upcoming project, survey permission and to answer any questions you may have regarding the survey or the Survey Permission form. Upon completion of the survey, if it is determined that the pipeline route will cross your property, the Agent will contact you to make an offer for the purchase of an easement or other rights.

As you may be aware, Texas law requires that a private entity with eminent domain authority must provide the Texas Landowner's Bill of Rights to the last known address of the person(s) listed as the property owner(s) on the most recent tax roll whose lands may be affected by the project, before or at the same time as the private entity first represents in any manner that it possesses eminent domain authority. In compliance with such law, enclosed for your review is a copy of The Texas Landowner's Bill of Rights. This document was prepared by the Office of the Attorney General of Texas for distribution to Landowners and is designed to make you aware of your rights as a Landowner when being approached by companies having the right of eminent domain.

Please understand that Magellan Pipeline Company, L.P. is sending this information to you as required by law prior to the beginning of negotiations. If it is determined that an easement or other rights will need to be acquired from you for the project, it is the desire of Magellan Pipeline Company, L.P. to negotiate a mutually acceptable agreement with you for the acquisition of such rights.

We look forward to working with you or your representatives to reach a satisfactory conclusion for all parties concerned.
