## AMENDMENT NO. 1

(b) Notwithstanding anything to the contrary, as long as Declarant retains an ownership interest in the property, Declarant shall have the right at anytime, at its sele discretion and without any joinder or consent of any other party, to amend this Declaration for the purposes of correcting any error, ambiguity or inconsistency appearing herein. Said amendment shall be effective upon filing of the instrument containing such amendment in the office of the County Clerk of Gillespie County, Texas.

In all other respects, the provisions of the Declaration of Covenants, Conditions and Restrictions of Grobe-Lich Ranch Subdivision, as amended, shall continue in full force and effect as written without change.
