

METES AND BOUNDS DESCRIPTION 147.568 ACRES

All that certain tract or parcel containing 147.568 acres of land in the Richard Hooper Survey, A-304, Harrison County, Texas, being all of the following four (4) tracts: (1) the residue of a tract which was called 147.833 acre, Tract One, (2) a tract which was called 35.00 acre, Tract Two, (3) a tract which was called 30.00 acre, Tract Three and (4) a tract which was called 15.00 acre, Tract Four, all four tracts being conveyed from Amelie H. Moffett to Mara Diane Snyder Davis, by an instrument of record in Volume 4149, Page 1, HCOPR, said 147.568 acres being more particularly described by metes and bounds as follows, basing bearings on the Texas Coordinate System of 1983, North Central Zone, to wit:

BEGINNING at a 1/2" iron rod found for a southeast corner, being the southeast corner of said Tract One and northeast corner of a tract which was called 52.969 acres conveyed from Eugene O. Fielder, et al to Dean Carter, et ux, by an instrument of record in Clerks File #2020-000014335, HCOPR, lying in the west line of a tract which was called 24.53 acres conveyed from Richard G. Rogers, et ux to David Von Fry, et ux, by an instrument of record in Volume 1302, Page 779, HCOPR;

THENCE S87°56'42"W, 1,580.79 feet along the common line of said Tract One and said 24.53 acre tract to a 6" metal fence corner post found for southwest corner, being the southwest corner of said Tract One and northwest corner of said 24.53 acre tract, lying in the east right of way (R-O-W) line of Maple Springs Road;

THENCE N05°16'21"E, along the common line of said Tract One and Maple Springs Road, at 1527.13 feet pass a 5/8" iron rod set for reference and continuing for a distance in all of 1,607.13 feet to a point for northwest corner, being an interior corner of said Tract One and the beginning of a curve, lying in the south line of a tract which was called 75.30 acres conveyed from Mara Diane Snyder Davis to Christopher Tucker, by an instrument of record in CF #2018-000004648, HCOPR and generally in the centerline of County Club Road;

THENCE departing Maple Springs Road, 267.18 feet along the arc of a curve to the left and common line of said Tract One, said 75.30 acre tract and County Club Road, (Delta= 38°16'16", Radius= 400.00 feet, Chord= N69°02'40"E, 262.24 feet), to a point for corner, being an angle point of said Tract One and said 75.30 acre tract;

THENCE N49°54'32"E, 319.52 feet continuing along said common line to the beginning of a curve;

THENCE 263.17 feet along the arc of a curve to the left and said common line, (Delta= 07°52'19", Radius= 1,915.43 feet, Chord= N45°36'40"E, 262.96 feet), to a point for corner, being an angle point of said Residue Tract and said 75.30 acre tract;

THENCE N41°06'44"E, 544.12 feet continuing along said common line to a point for corner, being an angle point of said Residue Tract and said 75.30 acre tract;

THENCE N42°03'11"E, 570.61 feet along the common line of said Residue Tract, said 75.30 acre tract, said Tract Four and County Club Road to a nail found for southeast corner of said 75.30 acre tract and the beginning of a curve, from which a 5/8" iron rod found bears: N34°34'03"W, 25.02 feet;

THENCE 324.22 feet along the arc of a curve to the right along the common line of said Tract Four and County Club Road, (Delta= 20°17′50″, Radius= 915.22 feet, Chord= N51°33′38″E, 322.52 feet), to a point for corner;

THENCE N63°45′56″E, 422.18 feet continuing along said common line to a point for corner, being an angle point of said Residue Tract;

THENCE N61°46'36"E, 420.61 feet along the common line of said Tract Four, said Tract Two and County Club Road and the beginning of a curve;

THENCE 297.56 feet along the arc of a curve to the right and said common line, (Delta= 03°58'30", Radius= 4,289.22 feet, Chord= N64°45'37"E, 297.50 feet), to a point for northeast corner;

THENCE departing County Club Road, S02°35'42"E, along the east line of said Tract Two, at 27.05 feet pass a 3/8" iron rod found for reference and northwest corner of a tract which was called 1.66 acres conveyed from Jackie Diane Reese to Robert Earl Reese, by an instrument of record in Volume 2777, Page 94, HCOPR, continuing along the common line of said Tract Two, said 1.66 acre tract and a tract which was called 148.86 acres conveyed from Reese-Mikhail Properties, LLC to Imad M. Moussa, et ux, by an instrument of record in Clerks File #2018-00007344, HCOPR, at 2,428.56 feet pass a wood fence corner post found for reference of said 148.86 acre tract and continuing along the common line of said Tract Two and said 148.86 acre tract for a distance in all of 2,446.89 feet to a point for southeast corner, being an interior corner of said 148.86 acre tract, generally lying in the centerline of a creek:
