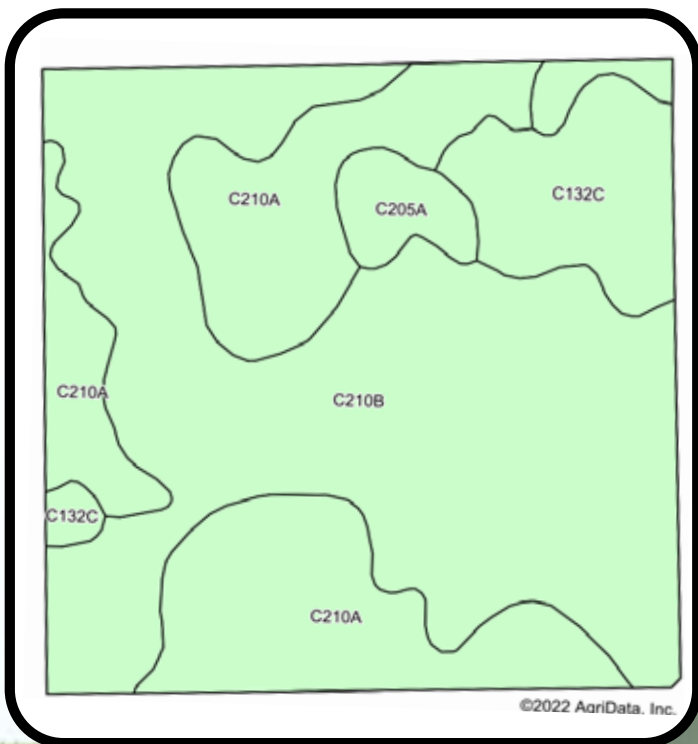

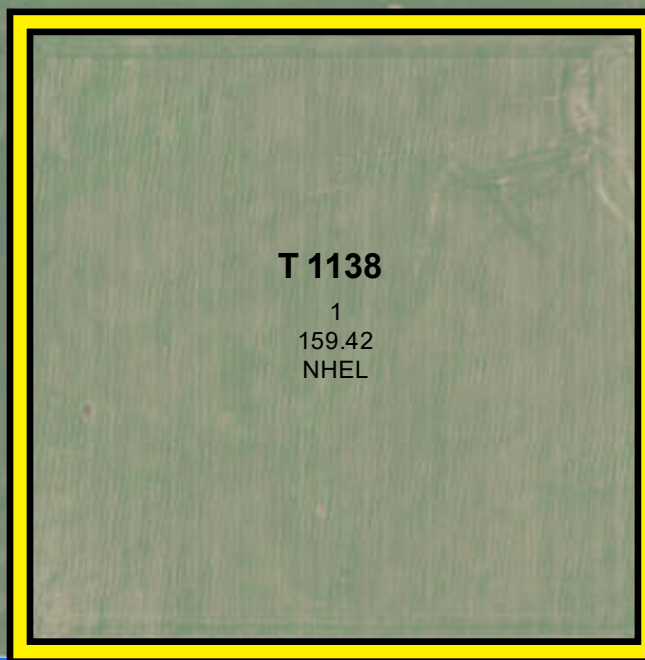

General Information

I. Terms and Conditions of Auction

A.
