FIELD NOTES OF 0.501 ACRE OF LAND

Being 0.501 acre of land situated in the Richard Hooper Survey, A-304, Harrison County, Texas, and being out of the northwest corner of that certain 3.000 acres tract of land described in deed from A & L Stiles Family Limited Partnership LTD. to Top Caliber Investments, LLC recorded under Document No. 2019-000008908, in the Office of the County Clerk, Harrison County, Texas (OCCHCT), and being more particularly described as follows:

BEGINNING at a PK nail found in the centerline of Country Club Road (also known as County Road 3429) for the NW Corner of said 3.000 acres tract and being S 62 deg 14' 38" E, 96.42 feet, from a PK nail found in said centerline for the NW Corner of the 2.000 acres residue of the A & L Stiles Family Limited Partnership LTD. 5.000 acres tract (Deed Reference: Doc. No. 2016-000012511, OCCHCT);

THENCE: With said centerline and with the north line of said 3.000 acres tract, S 63 deg 11' 55" E, 22.88 feet, to a PK nail found for angle point and S 65 deg 47' 40" E, 137.98 feet, to a PK nail found for the NE Corner of this tract, from which a PK nail found in said centerline for angle point in the north line of the 3.000 acres tract bears S 67 deg 38' 39" E, 65.50 feet;

THENCE: SOUTH, across said 3.000 acres tract, at 30.00 feet passing a capped (RPLS 4445) 3/8" steel rebar set for reference and continuing for a total distance of 99.66 feet, to a capped (RPLS 4445) 3/8" steel rebar set for the SE Corner of this tract;

THENCE: S 84 deg 44' 02" W, continuing across the 3.000 acres tract, 162.81 feet, to a capped (RPLS 4445) 3/8" steel rebar set in the west line of the 3.000 acres tract for the SW Corner of this tract and being N 04 deg 59' 26" E, 234.93 feet, from a capped (ARKLATEX) ½" steel rebar found for the SW Corner of the 3.000 acres tract;

THENCE: N 04 deg 59' 26" E (bearing basis per said Doc. No. 2019-00008908), with said west line of the 3.000 acres tract, at 152.13 feet passing a capped (ARKLATEX) ½" steel rebar found for reference and continuing for a total distance of 182.19 feet, to the POINT OF BEGINNING and containing 0.501 acre of land.
