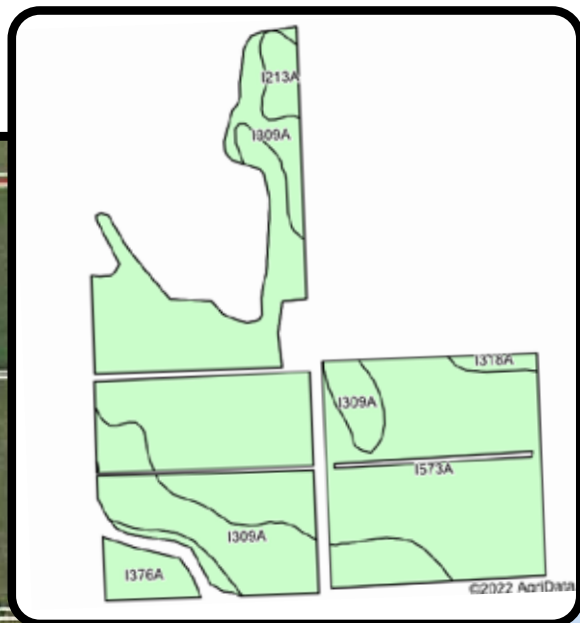
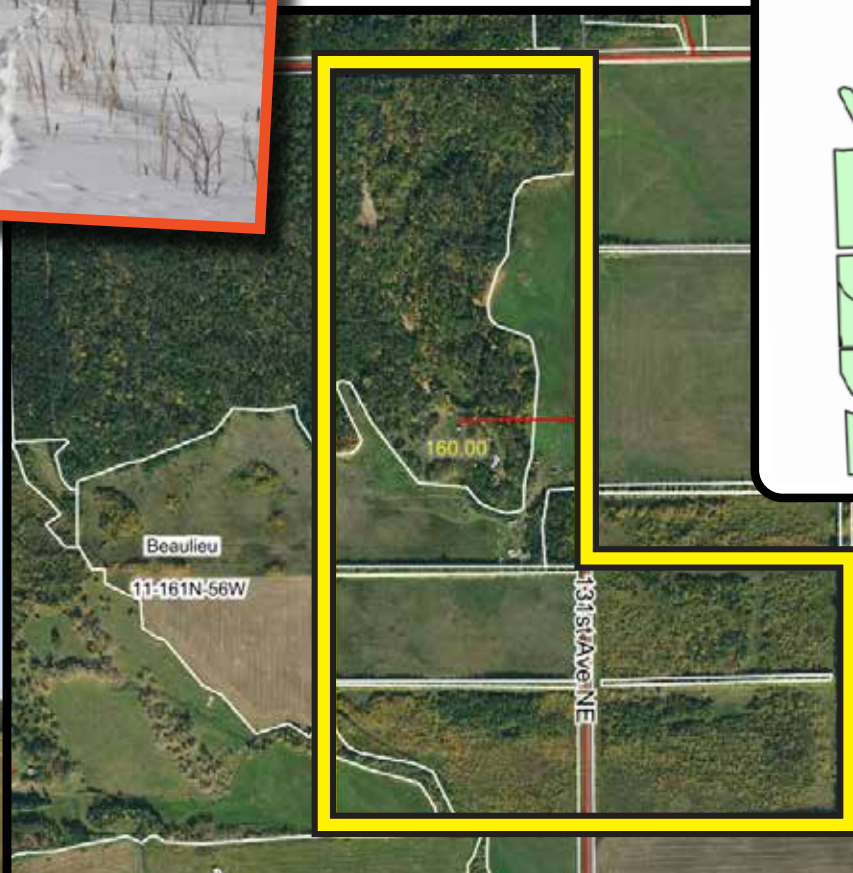
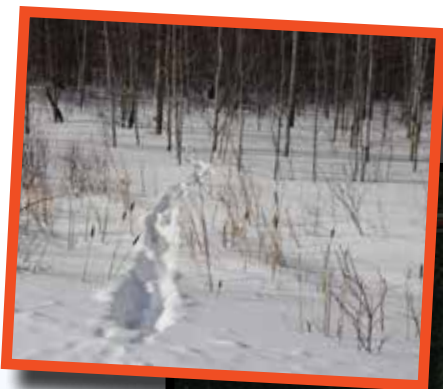
This parcel features prime hunting land with majority of it being woods. The property borders North Dakota Game & Fish land on the north and majority of the west side.

Terms & Conditions

I. Terms and Conditions of Auction

A. II. Bidding Procedures

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area
