FIELD NOTES TO DESCRIBE

Generally along fence and the West line of said Tract 96, S 09-08-46 E 531.24 feet to a 5/8" iron pin found by a 2" diameter pipe post for the North corner of that certain 19.91 acres of land, more or less, described as Tract 97 of said Concan Ranch Subdivision in a Deed to Robert Arredondo & Rose Arredondo from Western American National Bank, dated November 7, 2003, as recorded in Instrument No. 2007003130 of the said Official Public Records, the East corner of that certain 14.91 acres of land, more or less, described as Tract 14 of said Concan Ranch Subdivision in said Deed to Nancy L. Harkins, and the Southeast corner of this survey;

N 65-55-18 E 88.60 feet to an angle point;

N 35-14-14 E 50.34 feet to an angle point;

N 14-32-26 E 173.18 feet to an angle point; and

N 20-48-53 E 210.44 feet to the POINT OF BEGINNING.
