## **Rules & Regulations**

- 2.** Eligible Properties in the SIC bonus program will be appropriately identified. This information will be placed into the remarks portion of the MLS data sheet which will be placed in the MLS for all realtors to be able to easily identify which properties qualify. The code will be "SIC."
- 3.** Every time 100 SIC homes have closed, a drawing from eligible official entry cards will take place to determine a \$10,000 winner.
- 4.** We will announce the winner LIVE on-air. The name will be drawn by a morning show host on an Austin radio station.
- 5.** The sum of \$10,000 will be awarded to the winner of each drawing. The check will be made to the selling realtor company to which they have their license under. The "Winning" realtor's broker is to determine how the check is to be paid as they see fit.
- 6.** Each eligible SIC home sold and closed, and for which commission has been received from the seller, will entitle the selling realtor to one official entry card in the \$10,000 award program.
