FIELD NOTE DESCRIPTION 22.457 ACRES IN THE THOMAS Y. LOGWOOD SURVEY, ABSTRACT NUMBER 346, AND THE G.C. MCCOPPEN SURVEY, ABSTRACT NUMBER 414 BOWIE COUNTY, TEXAS

BEING a 22.457 acre tract of land situated in the Thomas Y. Logwood Survey, Abstract Number 346, and the G.C. McCoppen Survey, Abstract Number 414, Bowie County, Texas, being all of the certain called 22.38 acre tract described as Parcel 3, Tract 5, in instrument to Maya, Timber, LLC., recorded under Clerk's File Number 201900003023 of the Deed Records of Bowie County, Texas (D.R.B.C.T.), said 22.457 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a 1 ½ inch iron pipe found in the apparent northerly line of said Logwood Survey, the apparent southerly corner of John W. Weaver Survey, Abstract Number 641, and the John Barkman Survey, Abstract Number 52, for a common corner of said 22.38 acre tract, an unknown tract, and that certain called 278.238 acre tract described in instrument to Russell Marshall and Laquita Marshall, recorded in Volume 5956, Page 50, D.R.B.C.T., being the most northerly northwest corner of the herein described 22.457 acre tract, from which ½ inch iron rod found for reference bears, South 82°10′02" West, 0.19 feet;

THENCE North 88°12'10" East, 610.37 feet, along the northerly line said Logwood Survey and said McCoppen Survey, common to the apparent southerly line of said Barkman Survey, with the common line between said 22.38 acre tract and said 278.238 acre tract, to a ½ inch iron rod with cap stamped "TPS 100834-00" set in the approximate centerline of County Road 4284 (CR 4284), for the northeasterly corner of the said 22.38 acre tract and the herein described 22.457 acre tract, from which a 5/8 inch iron rod found for reference bears, North 88°12'10" East, 320.82 feet;

THENCE with the easterly line of said 22.38 acre tract, along the approximate centerline of said CR 4284, the following

- 9. South 32°06'11" West, 273.88 feet, to a calculated point for corner;
- 10. South 29°25'23" West, 200.15 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the common easterly corner of said 22.38 acre tract and that certain called 5.000 acre tract described in instrument to Christene Faulknor, recorded under Instrument Number 2017-11429, D.R.B.C.T., being the southeasterly corner of the herein described 22.457 acre tract;

THENCE North 85°13'40" West, with the common line between said 22.38 acre tract and said 5.000 acre tract, at a distance of 40.00 feet, pass a ½ inch iron rod with cap stamped "TPS 100834-00" set for reference in the northwesterly margin of said CR 4284, in all, a total distance of 1,130.89 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set in the easterly line of said 278.238 acre tract, for the common westerly corner of said 22.38 acre tract and said 5.000 acre tract, being the southwesterly corner of the herein described 22.457 acre tract;

THENCE North 01°53'49" West, 565.19 feet, with the common line between said 22.38 acre tract and said 278.238 acre tract, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the common westerly corner of said 22.38 acre tract and said unknown tract, for the most westerly northwest corner of the herein described 22.457 acre tract, from which a 1 inch iron pipe found for reference bears, North 03°34'20" West, 147.65 feet;

THENCE North 88°12'10" East, 572.66 feet, with the common line between said 22.38 acre tract and said unknown tract, to a 1½ inch iron pipe found (bent) for a common corner of same, being an interior corner of the herein described 22.457 acre tract, from which a ½ inch iron rod found (bent) for reference bears, South 88°04'29" West, 0.12 feet;

THENCE North 01°45'34" West, 171.20 feet, continuing with said common line, to the POINT OF BEGINNING;

CONTAINING a computed area of 22.457 acres of land within this Field Note Description.
