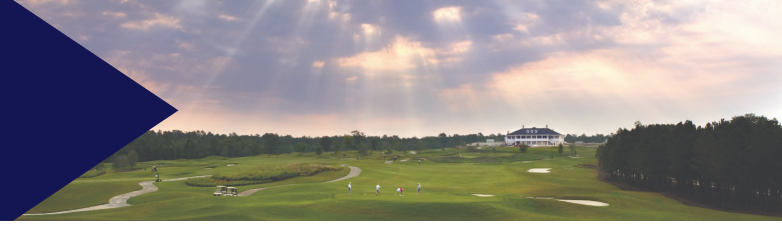

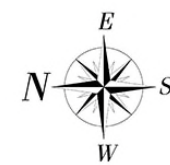

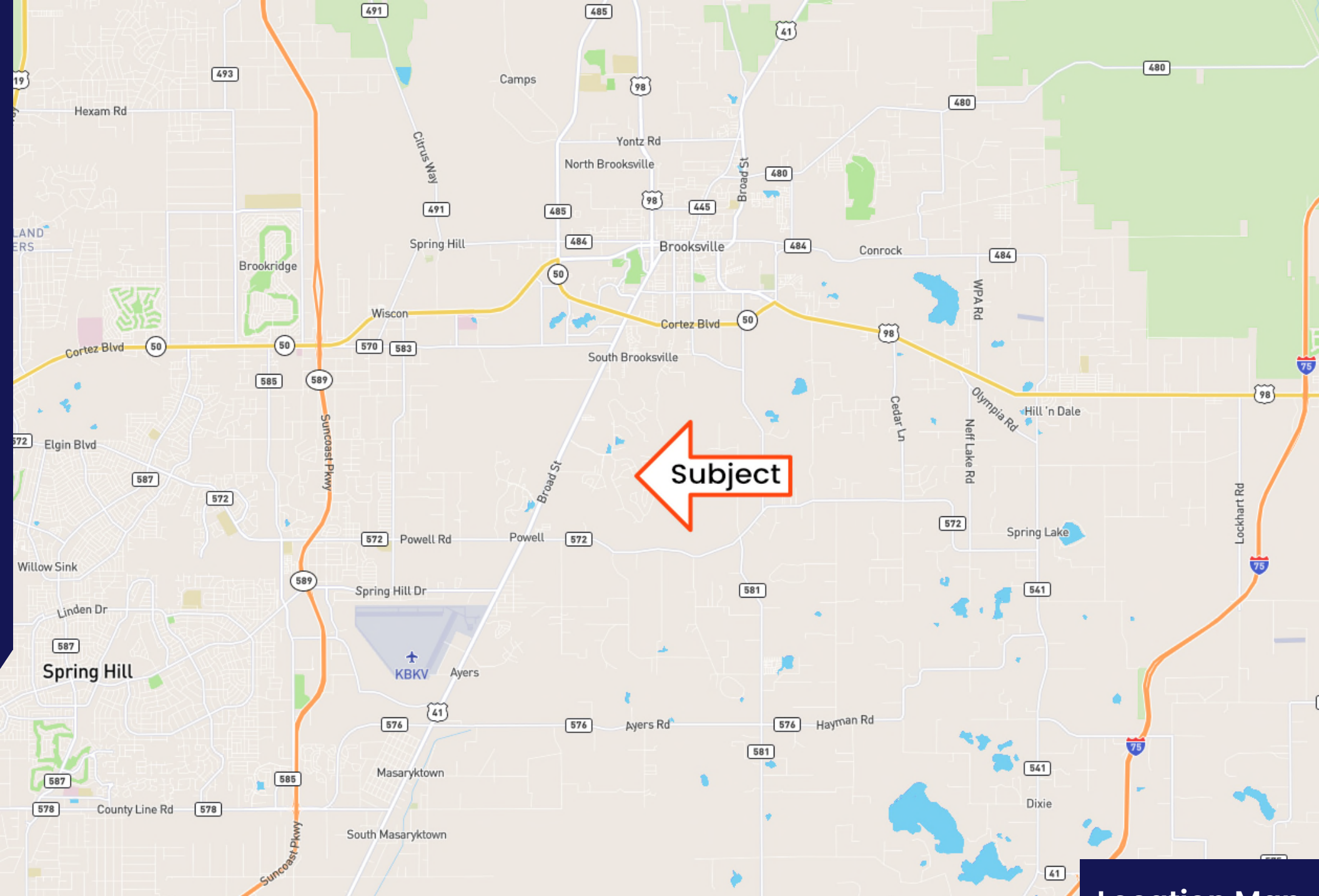

Community Site Plan

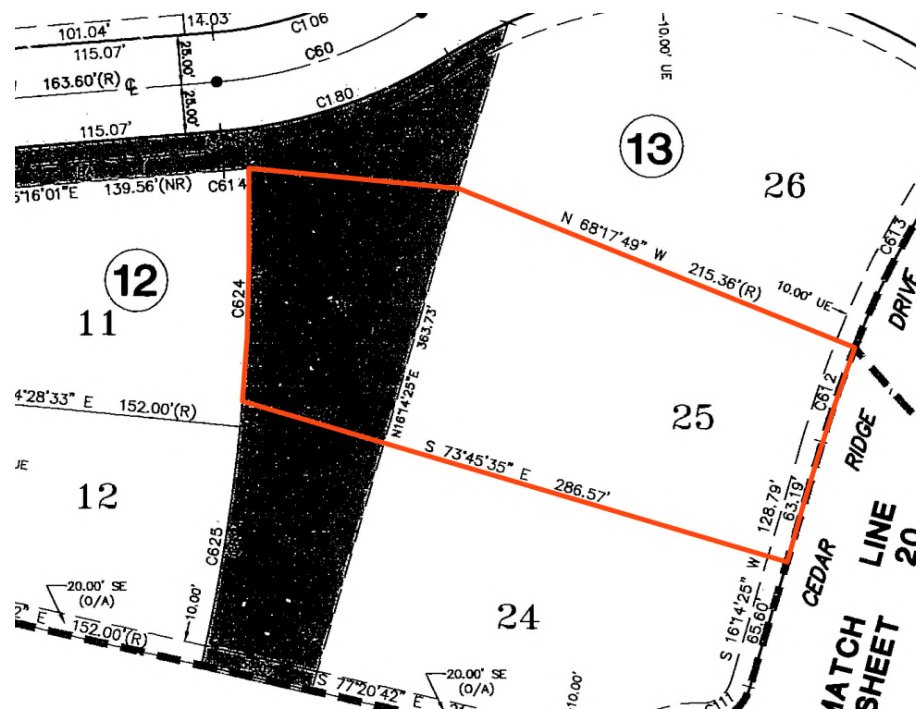


Location Map
