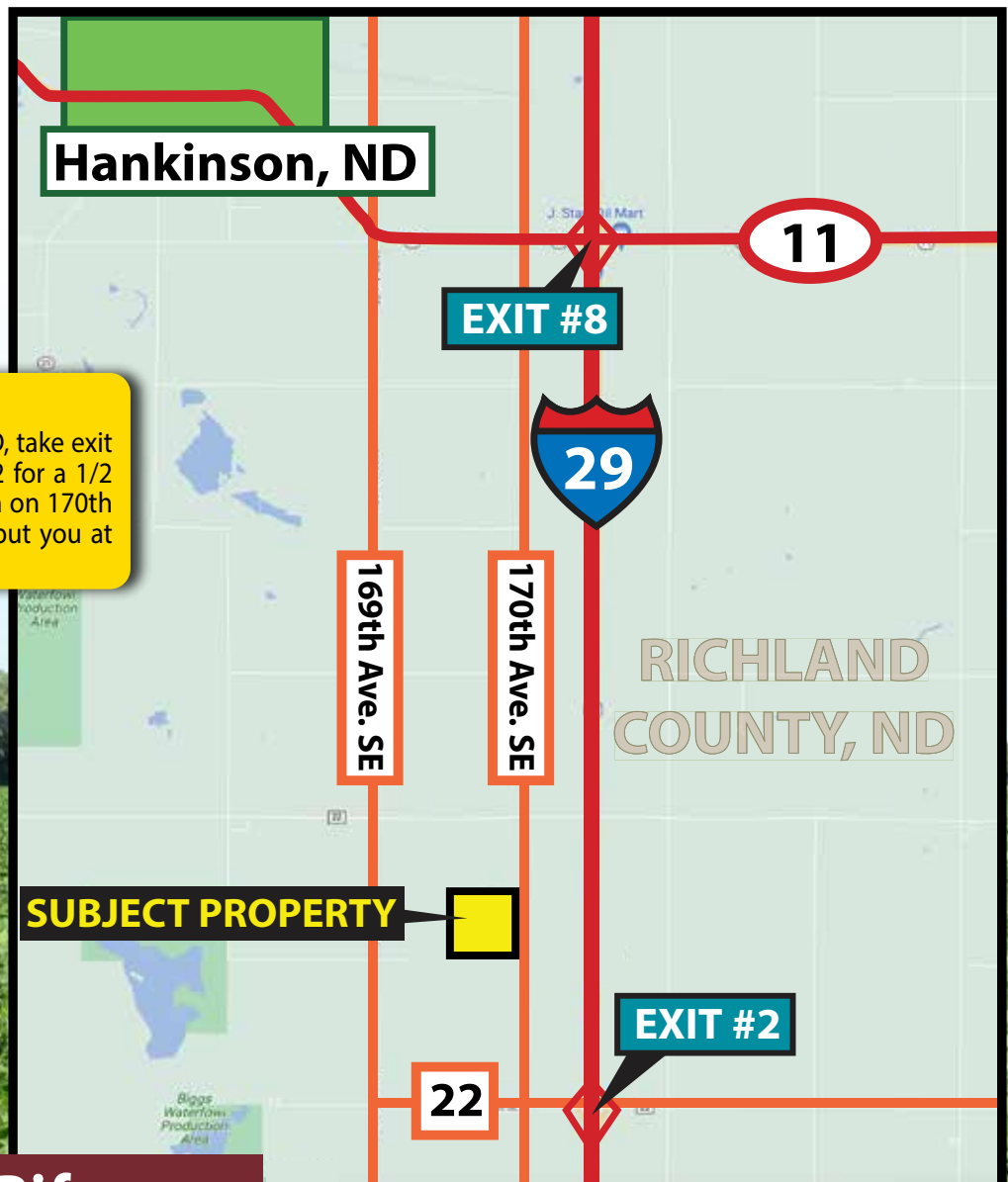
General Information

AUCTION NOTE: This is exceptional cropland in Greendale Township southeastern North Dakota. This historic farm is well known throughout the region for winning the North Dakota Soybean Yield Contest (67.1 bushels) and the North Dakota Corn Yield Contest (179.02 bushels) in the 1980s. What's more, this farm also was the 1970 Soil Conservationist Award Winner.

This cropland features nearly all Class II Soils, mostly Glyndon-Mantador-Tiffany Silt Loam and Mantador-Delamere-Wyndmere Soils. The Soil Productivity Index (SPI) is 71.5 covering 155.06 +/- crop acres. This is a live auction with Internet bidding available. This cropland is subject to a lease in 2022 but available for the 2023 crop season.

Driving Directions

On I-29 south of Hankinson, ND, take exit #2. Go west on County Rd. #22 for a 1/2 mile to 170th Ave. SE. Go north on 170th Ave. SE for one mile. This will put you at the SE corner of the property.

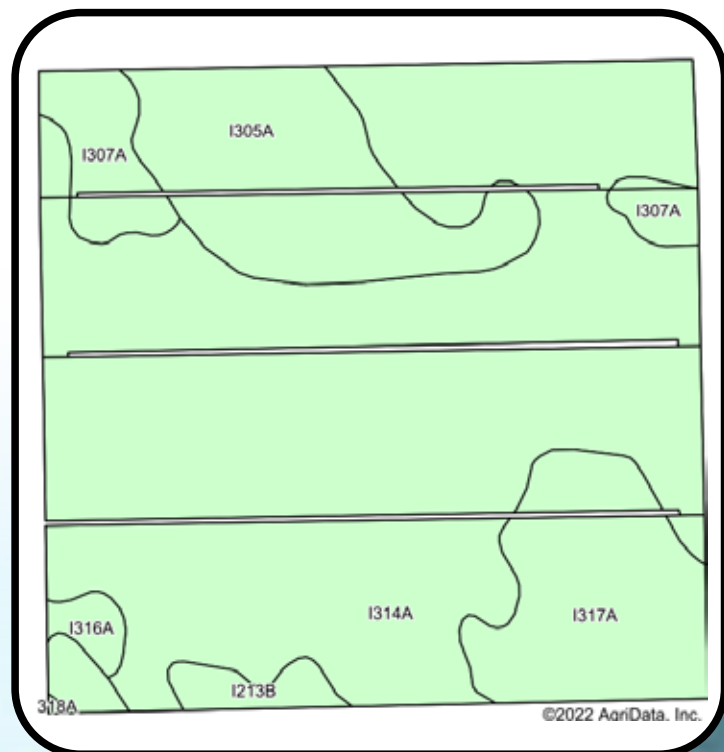

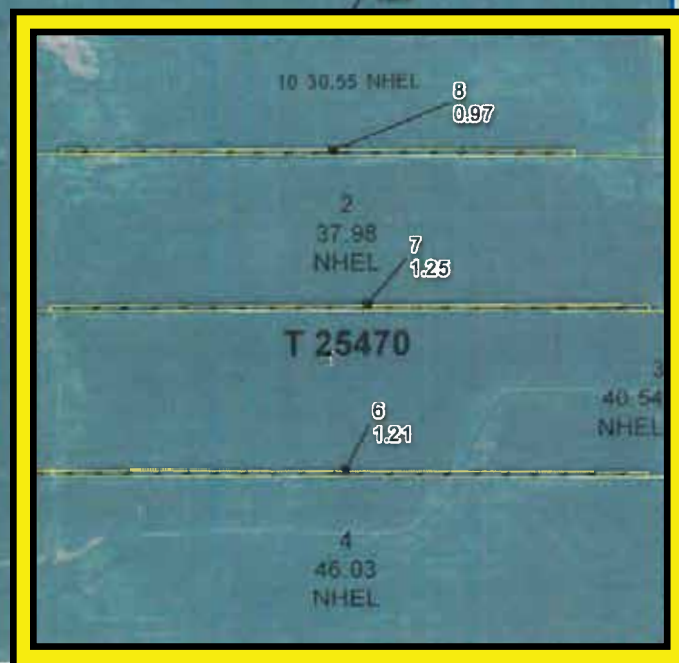

Terms & Conditions

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A. If you intend to bid on this property, you will be required to provide a cashier's check or personal check in the amount of 10 percent of the purchase price as earnest money on the date of the auction. II. Bidding Procedures

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area
