## Amendment to the Declaration of Restrictive and Protective Covenants for Bell Forest

On this <u>14</u> day of March, 2022, **Rock Bluff Ranch, Inc., a Florida Corporation**, hereby amends the Declaration of Restrictive and Protective Covenants for Bell Forest as Per Plat Book 3, Pages 31 and 32 that was recorded in O.R. Book 222, Page 576 of the Public Records of Gilchrist County, Florida (hereinafter referred to as "Declaration"), as follows:

WHEREAS, the plat of Bell Forest was recorded in Plat Book 3, Pages 31 and 31 of the Public Records of Gilchrist County, Florida (hereinafter referred to as "Subdivision");

WHEREAS, the Declarations provide at paragraph 8 that the Declarations may be amended by the then owners of not less than two-thirds of the lots in the Subdivision; and

WHEREAS, Rock Bluff Ranch, Inc. owns 6 of the 8 lots in the Subdivision. Such is greater than the two-third minimum required to amend the Declarations.

NOW THEREFORE, the Declarations are amended to include the following paragraphs:

- 9. Only site built homes with a minimum square footage of 1,500 square feet can be constructed upon Lots 1, 2, 3 and 4.
- 10. The owners of Lots 1, 2, 3 and 4 shall be responsible for maintaining the black colored, board fencing that exists along U.S. Hwy. 129 in its current condition as of the date of this Amendment.
