This matter came before the Court for a bench trial February 12, 13, 14, and 18, 2013. On May 14, 2013, the Court entered its Findings of Fact, Conclusions of Law, and Order, which Order is incorporated herein.

In its May 14, 2013 Order, the Court Ordered as follows:

- 1. The Main Road and Hoolie Springs Jog are public roads that have not been abandoned.
- 2. The West Reservoir and Ditch Company has acquired a right of access over the Main Road and the Headgate Jog for access to and maintenance of its reservoirs, ditches, and headgates.

Having so previously found and ordered, and pursuant to C.R.C.P. 57 and 65, the Court HEREBY ENTERS JUDGMENT in favor of Plaintiffs and against Defendants, and ORDERS as follows:

The Main Road and Hoolie Springs Jog are HEREBY DECLARED to be public rights-of-way pursuant to 43 U.S.C. § 932, C.R.S. § 43-1-202, and C.R.S. § 43-2-201(1)(e). The surveyed legal descriptions of the Main Road and the Hoolie Springs Jog are attached hereto as

Exhibit A. The Main Road and Hoolie Springs Jog public rights-of-way are deemed to have a width of 50 feet total, 25 feet on either side of the centerline as described in Exhibit A.

It is further DECLARED THAT The West Reservoir and Ditch Company, and its successors, successors in interests, heirs, agents, and assigns, have an unrestricted right of access across the Main Road and the Headgate Jog in order to access its reservoirs, ditches, and headgates and to otherwise conduct the operations of the Ditch Company. Such access specifically includes reasonable access across land currently owned by Defendants from the Main Road and/or the Headgate Jog to reasonably access the Ditch Company's reservoirs, ditches, and headgates. The surveyed legal description of the Headgate Jog is attached hereto in Exhibit A. The right-of-way of the Headgate Jog is deemed to have a width of 20 feet total, 10 feet on either side of the centerline as described in Exhibit A.

The Court ENJOINS AND ORDERS Defendants to remove all obstructions from the Main Road and Hoolie Springs Jog, including without limitation, any locks and chains, gates, or any other mechanism which impedes Plaintiffs' and the public's free access to the Main Road and Hoolie Springs Jog. Nothing in this order shall preclude any party from installing and maintaining appropriate cattle guards where the rights-of-way cross property boundaries. Defendants and their successors, successors in interest, heirs, and assigns are further PERMANENTLY ENJOINED from blocking, obstructing, impeding, damaging, or destroying the Main Road and Hoolie Springs Jog, or taking any other action that would interfere with the rights of Plaintiffs and the public to access, use, maintain, and improve the Main Road and/or Hoolie Springs Jog at any time in the future.

Defendants and their successors, successors in interest, heirs, and assigns are further PERMANENTLY ENJOINED from blocking, obstructing, damaging, or destroying the Headgate Jog, or taking any other action that would interfere with the rights of the West Reservoir and Ditch Company and its successors, successors in interests, heirs, agents, and assigns, to access, use, maintain, and improve the Main Road and the Headgate Jog in the future to reasonably access the Ditch Company's reservoirs, ditches, and headgates and to otherwise conduct the operations of the Ditch Company.

This Order and its Exhibit A shall be recorded in the Office of the Clerk and Recorder of Delta County, Colorado.
