GENERAL WARRANTY DEED

THIS DEED OF CONVEYANCE, made and entered into this day of December, 1996, by and between, DEBORAH LYNN RAY and husband, KEVIN LEE RAY, of 2910 Princeton Road, Hopkinsville, Kentucky 42240; ROBERT LEE WEBB and wife, TRACY KELLY WEBB, of 1675 Everett Lane, Hopkinsville, Kentucky 42240; ELIZABETH WEBB HESTER and husband, ERIC LYNN HESTER, 7920 Coventry Court, Evansville, Indiana 47715; and SANDRA WEBB BROWN and husband, JOHN THOMAS SAMUEL BROWN, of 8295 Greenville Road, Hopkinsville, Kentucky 42240, hereinafter referred to as "Grantors," and ROBERT LEE WEBB, a married person, of 1675 Everett Lane, Hopkinsville, Kentucky 42240; ELIZABETH WEBB HESTER, a married person, of 7920 Coventry Court, Evansville, Indiana 47715 and SANDRA WEBB BROWN, a married person, of 8925 Greenville Road, Hopkinsville, Kentucky 42240, hereinafter referred to as "Grantees;"

WITNESSETH:

THAT FOR AND IN CONSIDERATION of the division of real estate pursuant to the Last Will and Testaments of Lee F. Webb, Mable Webb, and Murrell Webb, the Grantors do hereby bargain, sell, alien and convey unto the Grantees, ROBERT LEE WEBB, a one-third (1/3) undivided interest, ELIZABETH WEBB HESTER, a one-third (1/3) undivided interest, and SANDRA WEBB BROWN, a one-third (1/3) undivided interest as tenants in common, the following described property lying in Carlisle County, Kentucky, to wit;

PARCEL I

Webb and wife, Mable Webb, as joint tenants with right of survivorship, by deed from Martha Jackson, et al, dated the 21st day of November 1966 of record in Deed Book 61, page 106 of the Carlisle County Court Clerk's Office. Mable Webb derived title in full upon the death of Lee F. Webb pursuant to the survivorship clause in the above referenced Mable Webb died testate on the 24th day of March, 1996 leaving her 1/2 interest in subject property to her three children, Earl Webb, Murrell Webb and Elizabeth Webb (now Wienhardt) as evidenced by her Last Will and Testament probated on the 3rd day of April, 1996 and filed of record in Will Book 7, page 294, of the Carlisle County Court Clerk's Office. Murell Webb predeceased his mother, Mable Webb, and his interest in his mother's share of the above-described property passed to his surviving children, Elizabeth Webb Hester, Deborah Webb Ray, Robert Lee Webb and Sandra Webb Brown, pursuant to the Last Will and Testament of Mable Webb, probated on the 3rd day of April, 1996, and filed of record in Will Book 7, page 294, of the Carlisle County Court Clerk's Office.

PARCEL II

TRACT I: Beginning at the south east corner of the 100 acres tract of land bought by Allen Jones from W. F. Cammington and Akins at two white oak and two poplars; thence west 82 poles to a red oak, white oak and poplar; thence at 50.23 Acres to 1.23 Acres to 2.23 Acres to right angles North 98 poles to a stake; thence at right angles East 82 poles to a stake; thence S. 98 poles to the beginning.

Being the same property conveyed to Geo L. Webb by deed from D. L. Holder and wife, Susie Holder, dated the 19th day of January, 1903 and of record in Deed Book 12, page 184 of the Carlisle County Court Clerk's Office. G. L. Webb died intestate on March 8, 1926, leaving as his widow and only heir, his wife, Cassie Webb, a dower interest, and a son, Lee Webb, the entire interest. Cassie Webb died intestate in 1944, as evidenced by Affidavit of Descent of record in Deed Book 56, page 13, of the Carlisle County Court Clerk's Office. Lee Webb died testate leaving his wife, Mable Webb, a life estate in his real property with the remainder equally to his three children, Earl Webb, Murrell Webb, and Elizabeth Webb (now Wienhardt), as evidenced by his Last Will and Testament probated on October 24, 1978 and of record in Will Book 3, page 276, of the Carlisle County Court Clerk's Office. Mable Webb's life estate was extinguished upon her death on the 24th day of March, 1996. Murrell Webb died testate leaving all his interest in the subject property to his four children as follows: Elizabeth Webb Hester, a 2/5 undivided interest; Deborah Webb Ray, a 1/5 undivided interest; Robert Lee Webb, a 1/5 undivided interest; and Sandra Webb Brown, a 1/5 undivided interest, as evidenced by his Last Will and Testament probated on the 4th day of January, 1989, in the Christian County District Court, and filed of record in Will Book 7, page 516, of Carlisle County Court Clerk's Office.

And being in all respects a portion of the same property conveyed to the Grantors and Grantee by deed from Earl Lee Webb, et al, dated October 5, 1996, of record in Deed Book 104, page 115, of the Carlisle County Court Clerk's Office. The property conveyed herein being Parcels I and II in said deed.
