THENCE S 49°29'21" E a distance of 75.16 feet along said right-of-way line to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for corner;

THENCE crossing said Hackemack 79 acre tract S 77°32'12" W a distance of 1030.02 feet to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for corner and N 12°27'48" W a distance of 60.00 feet to point in the northerly line of said Hackemack 79 acre tract;

**BEGINNING** at a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set in the southwesterly right-of-way (100') line of FM Road 1457, conveyed by deed recorded in Volume 280, Page 510 of said deed records, for the northeasterly corner hereof and said Hackemack 79 acre tract and the southeasterly corner of that certain 67 acre tract of land conveyed to Percy Rudloff and Norma Rudloff by deed recorded in Volume 272, Page 116 of said deed records;

THENCE S 49°29'21" E a distance of 37.58 feet along said right-ofway line to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for corner;

THENCE crossing said Hackemack 79 acre tract and 73 acre tract the following three (3) calls:

- S 77°32'12" W a distance of 982.63 feet to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for reference and continuing an additional distance of 1937.79 feet to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for corner;
- 2. S 21°32'19" E a distance of 678.01 feet to a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for angle point;

S 51°37'17" E, passing a 1/2" iron rod with cap stamped "JE Garon RPLS 4303" set for reference at a distance of 1361.88 feet and continuing for a total distance of 1411.86 feet to a point for corner in Little Jacks Creek and by boundary line agreement recorded in Volume 1301, Page 1 of said official records;

THENCE S 70°19'27" W a distance of 1047.00 feet to a fence post found at angle point in fence line for the easterly corner of said Hackemack 10-2/5 acre tract and S 40°45'42" W, passing a fence corner post found at a distance of 654.69 feet and continuing for a total distance of 675.00 feet to a point in the northwesterly line of that certain 125.5 acre tract of land conveyed to Leslie Johnson by deed recorded in Volume 1380, Page 176 of said official records for the southerly corner of said Hackemack 10-2/5 acre tract and a corner of that certain 116.50 acre tract of land conveyed to Dorine Hall by deed recorded in Volume 973, Page 868 of said official records;

THENCE N 50°30'04" W a distance of 667.63 feet to a fence corner post found for the westerly corner of said Hackemack 10-2/5 acre tract and a corner of said Hall 116.50 acre tract;

THENCE S 41°43'21" W a distance of 550.61 feet to a fence corner post found for a corner of said Hackemack 73 acre tract and a corner of that certain 92 acre tract of land (Tract 1) conveyed to James Wolff and Larry Wolff by deed recorded in Volume 1632, Page 10 of said official records;

THENCE with the common line hereof with said Wolff 92 acre tract the following four (4) calls:

- 1. N 48°54'26" W a distance of 515.21 feet to a fence post found for angle point;
- N 00°47'36" E a distance of 968.93 feet to a fence post found for angle point;
- N 29°50'53" E a distance of 1010.64 feet to a fence post found for angle point and the northwest corner of said Hackemack 2.94 acre tract and a corner of said Hackemack 79 acre tract;
