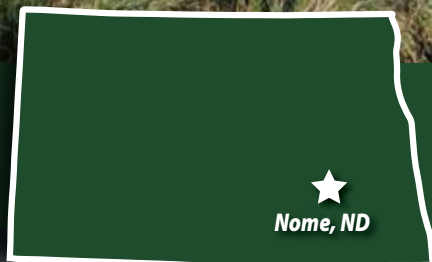

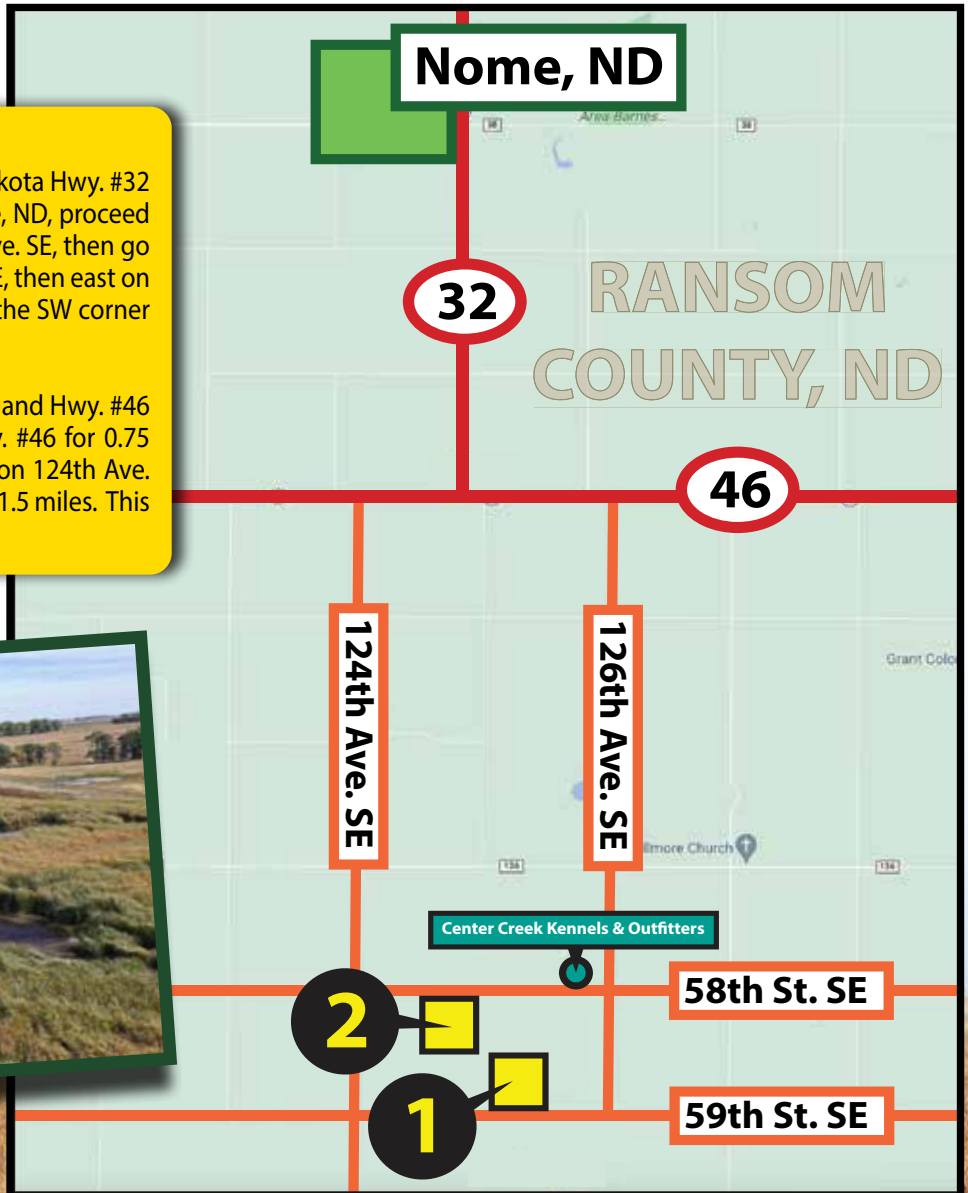
General Information

AUCTION NOTE: This is exceptional cropland with tremendous wildlife habitat and great hunting opportunities in Preston Township in Ransom County, ND. The 304.74 +/- crop acres features Soil Productivity Indexes (SPI) in the 60s and 70s! These two quarters also offer excellent waterfowl, deer and pheasant hunting. The Farm Service Agency (FSA) acres may not reflect planted acres.

Driving Directions

Parcel 1: From the intersection of North Dakota Hwy. #32 and North Dakota Hwy. #46 south of Nome, ND, proceed west on Hwy. #46 for 0.75 miles to 124th Ave. SE, then go 5 miles south on 124th Ave. SE to 59th St. SE, then east on 59th St. SE for 2 miles. This will put you at the SW corner of Parcel 1.

Parcel 2: From the intersection of Hwy. #32 and Hwy. #46 south of Nome, ND, proceed west on Hwy. #46 for 0.75 miles to 124th Ave. SE, then 4 miles south on 124th Ave. SE to 58th St. SE, then east on 58th St. SE for 1.5 miles. This will put you at the NW corner of Parcel 2.

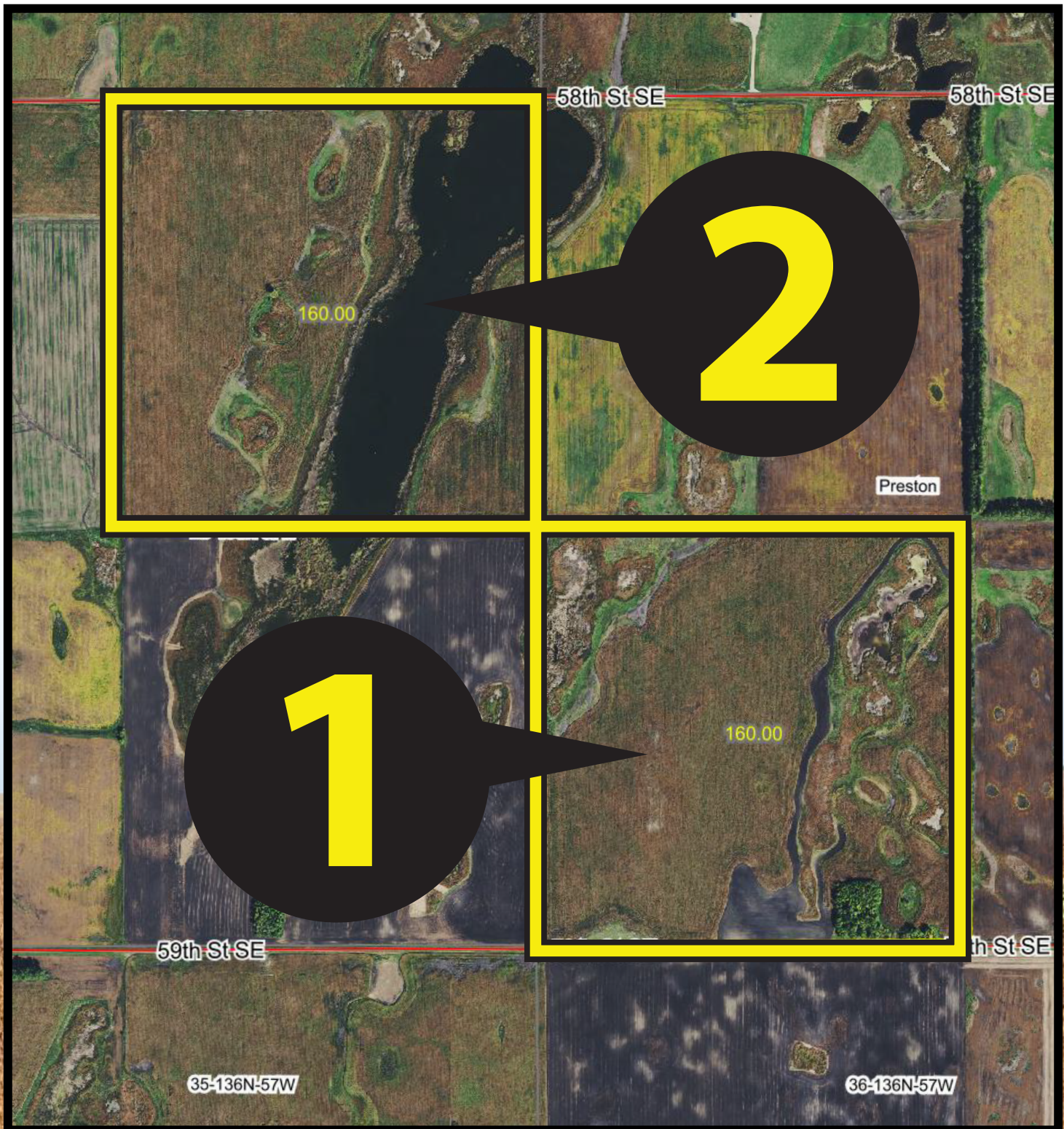

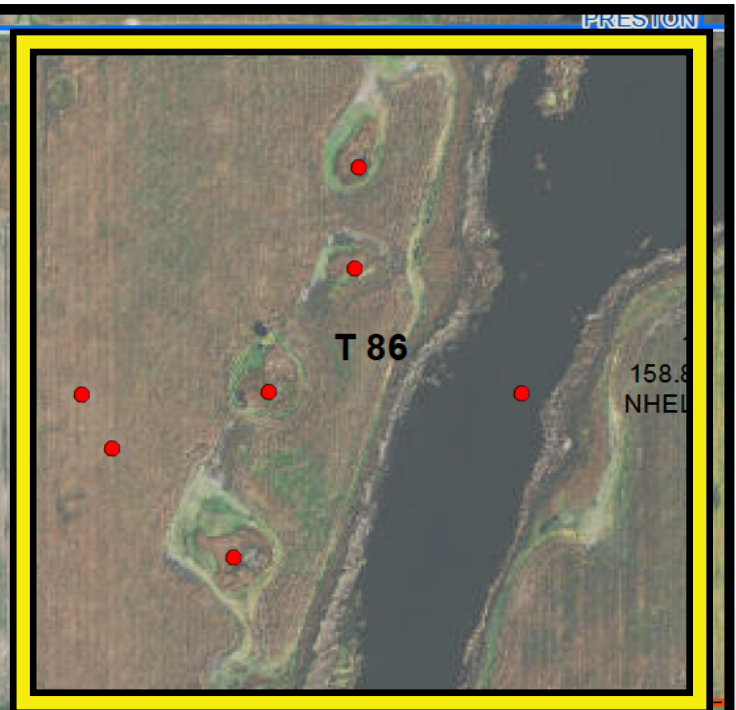

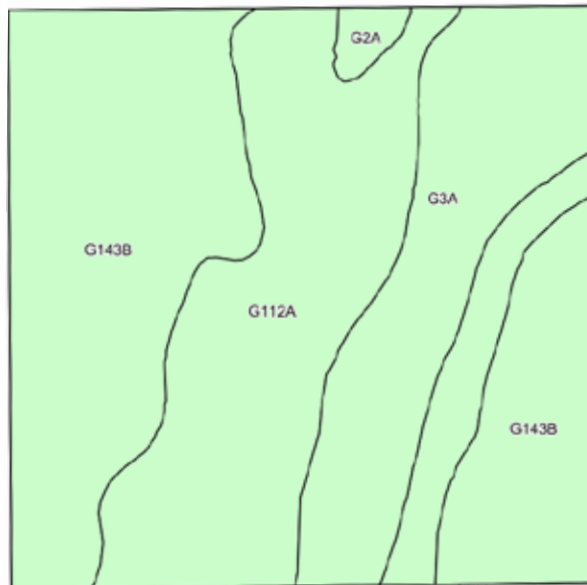

Terms & Conditions

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A. If you intend to bid on this property, you will be required to provide a cashier's check or personal check in the amount of 10 percent of the purchase price as earnest money on the date of the auction. B. If you are the highest bidder on any of this property, you will be required to deposit a check with the closing agent who will hold the money in escrow until the closing date. All documentation will be available for your review prior to commencement of the auction. All real estate sales must be closed and the total balance of the purchase price paid on or before 12/29/2022. After the auction sale you will be given an appointment date and time with the Closing Agent for a closing date to close the transaction.

II. Bidding Procedures

All bidding is open to the public. You need only to raise your hand and shout out your bid, or instruct any of the ring men to do so on your behalf. Anyone who wishes to bid must first register to obtain a bidder's card at the registration desk.
