



Survey and description of a 2.97 acre tract in the Northwest quarter of Section 32 Township 2 South, Range 2 West of the Chickasaw Cession in Marshall County, Mississippi being part of the John Ellis Company, LLC property as recorded by Instrument 2022002890 in the Marshall County Chancery Court clerks office and being more particularly described as: Commencing and beginning at a 6" x 6" concrete monument (FOUND) at the Northwest corner of said Section 32, said monument having a Mississippi State Plane East zone coordinate of North 1955660.55, East 801943.21; thence S 88°51'23" E along the North section line as monumented a distance of 2185.69' to a cotton picker spindle (FOUND) in Atway Road, said spindle having a Mississippi State Plane East zone coordinate of North 1,955,616.92, East 804,128.46 and being the true point of beginning; thence S 88°51'23" E a distance of 466.95' to a to a 6" x 6" concrete monument (FOUND) in a fence corner; thence S 00°14'23" W along a west line of the Mary Ann Weaver Lee property as recorded by Instrument 2015002297 (Tract 1, Plat File 748A&B Tract III) a distance of 121.62'to tpost (FOUND); thence S 00°01'22" E along said Lee tract a distance of 249.89' to a tpost (FOUND); thence S 03°12'22" W along said Lee tract a distance of 114.79'to a ½" rebar (FOUND); thence S 01°25'11" E a distance of 21.92'to a metal object detected in Atway Road; thence Northwestwardly along said Atway Road centerline the following courses: N 51°29'39" W 140.90', N 46°50'02" W 96.02', N 37°56'47" W 121.20', N 33°49'09" W 137.89', N 36°22'06" W 107.45', N 43°24'20" W 84.83', N 51°03'48" W 9.00', to the point of beginning, having an area of 129320.0 square feet, 2.97 acres. The bearings in this description are MSPCS East zone derived.
