THENCE South 30°19'10" West, along and with the said northwest right-of-way line and a fence, 184.68 feet to a 5/8 inch iron rod set in a fence line for an angle point in said northwest right-of-way line, same being the southeast corner of said "Tract 1" and being the northeast corner of said "Tract 2" and being an angle point in the east line of the herein described tract;

THENCE South 37°26'41" West, along and with the said northwest right-of-way line and a fence, 129.87 feet to a point in a fence line situated in the said northwest right-of-way line for the northeast corner of the Harris County Flood Control District Drainage Ditch and being the southeast corner of said "Tract 2" and the herein described tract, from which a found 5/8 inch iron rod bears North 73°10'25" East 13.76 feet;

Laws in Harris County Clerk File No. RP-2017-467282 in the Official Public Records of Real Property of Harris County, same being the easternmost southeast corner of said 6.4292 acre tract, at 281.79 passing a 1/2 inch iron rod found in a fence line for the southeast corner of said 0.6875 acre tract, same being the southwest corner of that certain called 0.6699 acre tract, per Harris County Appraisal District, at 382.41 passing a sucker rod found in a fence line for the southeast corner of said 0.6699 acre tract, same being the southwest corner of said 0.9199 acre tract, at 483.36 feet passing a 1/2 inch iron rod found in a fence line in the south line of said 0.9199 acre tract, continuing for a total distance of 566.70 feet to the **POINT OF BEGINNING** and containing 2.1007 acres of land, within this metes and bounds description, more or less.
