





Albemarle Phase 2: 2,419 Acres

Albemarle County, Virginia, 2419 AC +/-






CONSERVATION EASEMENT




In July 2019, the property was placed into a conservation easement with Albemarle Conservation Easement Authority joining a number of significant nearby properties and adding to Albemarle County's growing list of protected lands. At the end of 2020, Albemarle County had approx. 108,869 acres (over 23% of the county) in conservation.

The Thomas Jefferson Foundation has sought to preserve the rural character of Monticello's viewshed and of the entrance corridors leading to Monticello. This protected viewshed is the same one enjoyed by this property looking back towards Monticello meaning the spectacular views this property enjoys will remain largely unspoiled for many years to come.
