THENCE, NORTH 88° 59' 00" WEST, with the southerly line of said 28.455 Acre tract and Gallien's tract, a distance of 342.65 Feet to a 5/8 Inch iron rod found marking the southeast corner and **POINT OF BEGINNING** of this tract and the southwest corner of said Gallien's tract;

THENCE, continuing **NORTH 88° 59' 00" WEST**, with the southerly line of said 28.455 Acre tract and this tract, a distance of **352.94 Feet** to an angle point for corner;

THENCE, **NORTH 88° 52' 00" WEST**, with the southerly line of said 28.455 Acre tract and this tract, a distance of **78.20 Feet** to a 1/2 Inch iron rod with "Precision" cap set for the southwest corner of this tract;

THENCE, **NORTH 02° 53' 27" WEST**, across said 28.455 Acre tract and the southerly west line of this tract, a distance of **357.14 Feet** to a 1/2 Inch iron rod with "Precision" cap set for the westerly northwest corner of this tract;

THENCE, **NORTH 89° 53' 53" EAST**, across said 28.455 Acre tract and an interior line of this tract, a distance of **225.83 Feet** to a 1/2 Inch iron rod with "Precision" cap set for an interior corner of this tract;

THENCE, **NORTH 00° 06' 07" WEST**, across said 28.455 Acre tract and the northerly west line of this tract, a distance of **265.33 Feet** to a 1/2 Inch iron rod with "Precision" cap set in the north line of said 28.455 Acre tract and the south line of a called 81.214 Acre tract recorded in the name of Hammerhead Environmental Research Center, L.L.C. in Volume 987, Page 522 of the D.R.W.C.T. for the northerly northwest corner of this tract;

THENCE, **NORTH 89° 53' 53" EAST**, along with the north line of said 28.455 Acre tract and this tract and the south line of said 81.214 Acre tract, a distance of **222.60 Feet** to a 1/2 Inch iron rod with "Precision" cap set for the northeast corner of this tract;

THENCE, **SOUTH 00° 06' 07" EAST**, across said 28.455 Acre tract and the east line of this tract, at 431.80 Feet pass a 5/8 Inch iron rod found for the northwest corner of aforementioned Gallien's tract and continuing for total distance of **630.62 Feet** to the **POINT OF BEGINNING** containing 5.0000 Acres of land.
