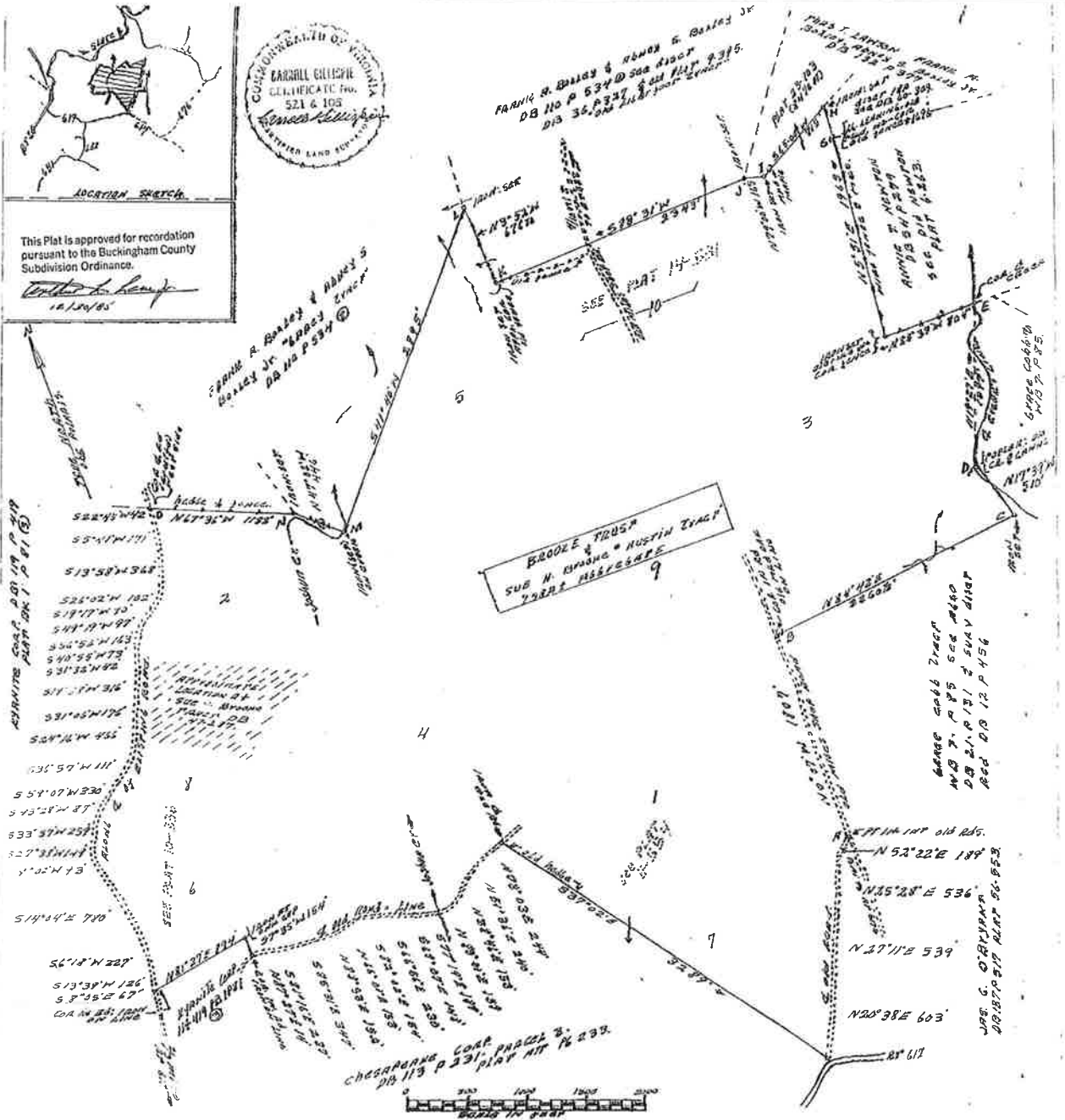


LOCATION SKETCH

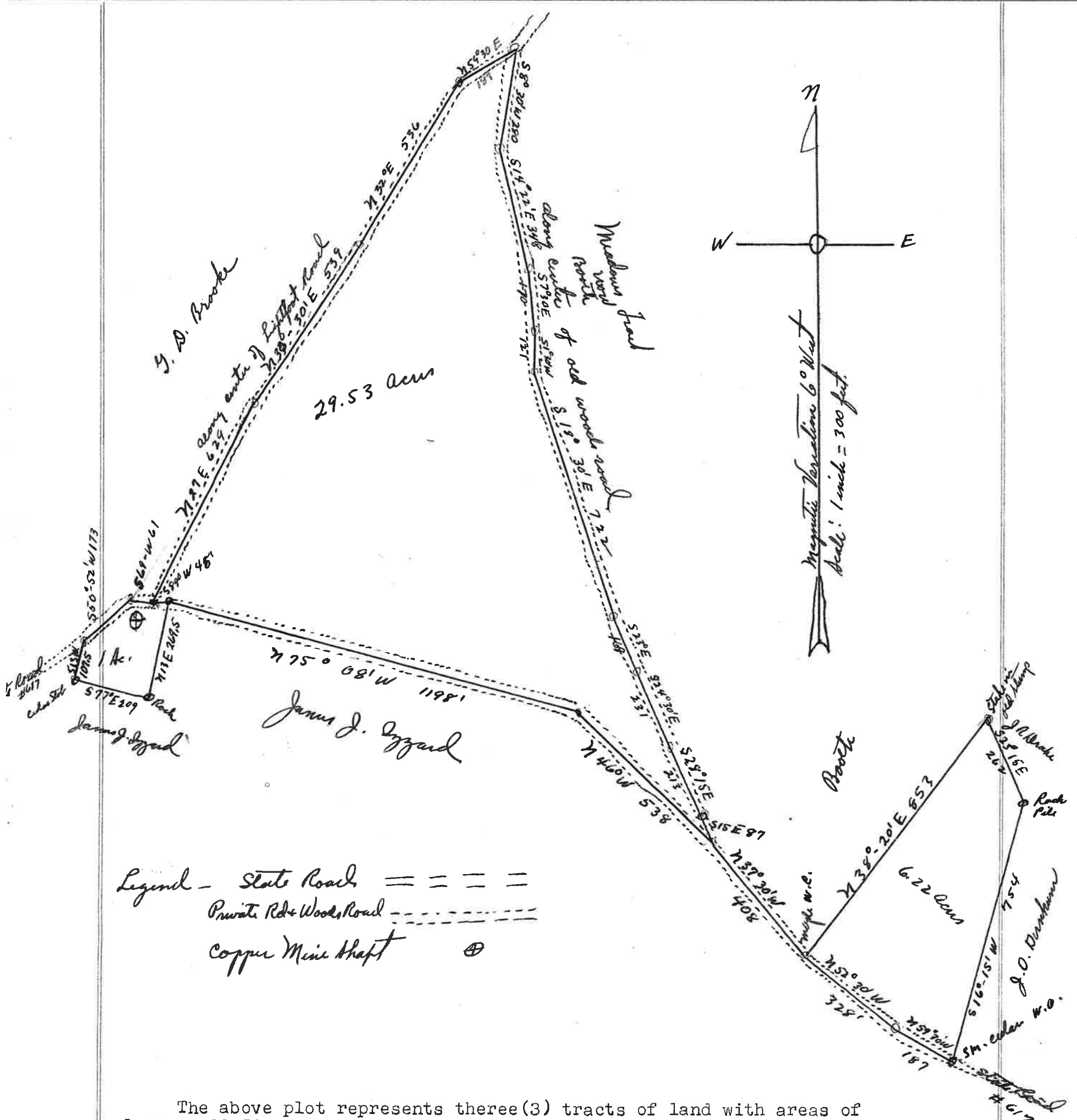
