

Located in Taylor County, Georgia, this property consists 69 +/-acres of 9-year-old longleaf planted pine, 76 acres of natural hardwood/pine, and a 3 +/- acre pond. The property has the potential to grow 155"-162" class whitetail bucks, plenty of turkeys and bobwhite quail. Property has proved to attract ducks on the pond in the past. The property is less than 10 miles from the Flint River. The property is conveniently located along HWY 96 between Butler and Reynolds. Georgia.

Hunting



Taylor County is known to provide great habitat and hunting for deer, turkey, quail. and ducks. Fall Line Recreational property has superior habitat and natural features that have made the property a great hunting tract for the owners for years.

A spring fed creek and pond provide a natural water source, hardwoods (white-oaks and red-oaks) provide a natural hard-mass food source, and young longleaf pine provide excellent bedding and cover habitat.









Timber Investment



Fall Line Recreational Property provides excellent wildlife habitat that can be enjoyed by the landowner, but the property can also serve as an investment for the landowner.

Timberland has proven to be a great hedge against inflation. This property has $69 \pm$ acres of long leaf pine and $70 \pm$ acres of natural hardwood and pine.

Longleaf pine and loblolly pine have traditionally grown very well throughout this region of Georgia. Bringing a landowner a passive investment from raking pine straw, carbon credits, and thinning timber. Taylor County often serves as a safety net for loggers, timber buyers, and mills in the wet winter seasons. The sandier soils of the region generally hold up better in the wet months and bring a higher stumpage price to the landowner due to a lower supply of accessible stumpage acres.

Fall Line Recreational Tract's close proximity to several wood consuming mills, also offers more competitive stumpage prices from a timber consultant or landonwer's marketing capability.








Wood Consuming Mills






