TIMBER:

The total acreage on the property is +/- 162 acres. Of that acreage, +/- 137 acres consists of a mature pine stand that contains mostly pine sawtimber with a small component of pine chip-n-saw, pine pulpwood, and hardwood pulpwood. Approximately +/- 11 acres consists of a moist soil area, +/- 6 acres is a pipeline right of way, and the remaining +/- 8 acres consists of roads.

The timber on the +/- 137 acres of mature pine was cruised in January, 2023 by Baker Land & Timber Management, Inc., utilizing a 5% systematic sample estimate for all sawtimber and pulpwood. Below are the estimated timber volumes by product class.

Pine Sawtimber - 11,735 Tons
Pine Chip-n-saw - 1,046 Tons
Pine pulpwood - 6,438 Tons
Hardwood Sawtimber - 45 Tons
Hardwood Pulpwood - 227 Tons

No timber cruising was done in the +/- 11 acre moist soil area.
