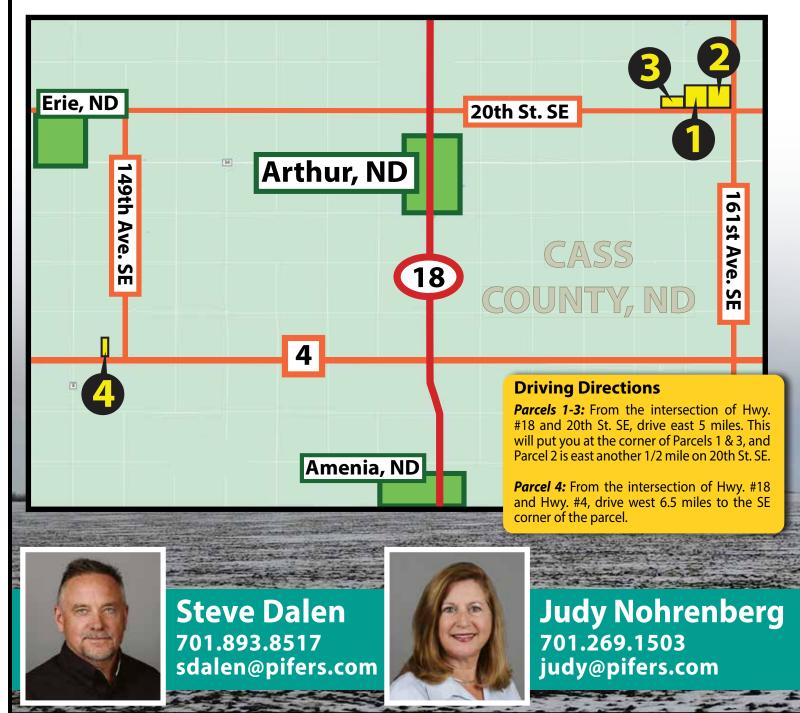




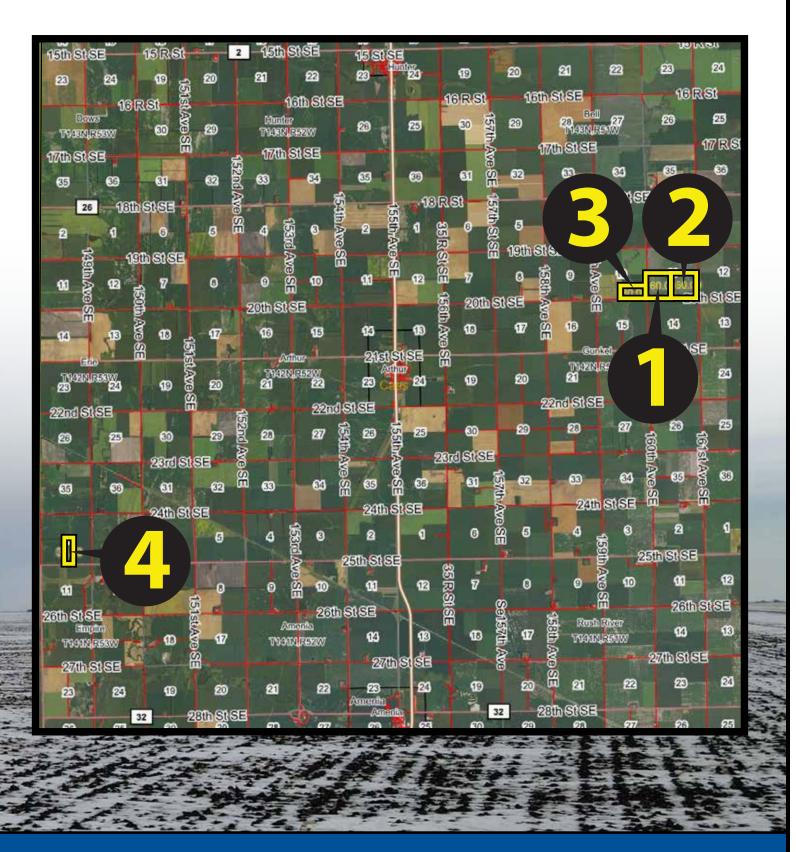


#### **General Information**

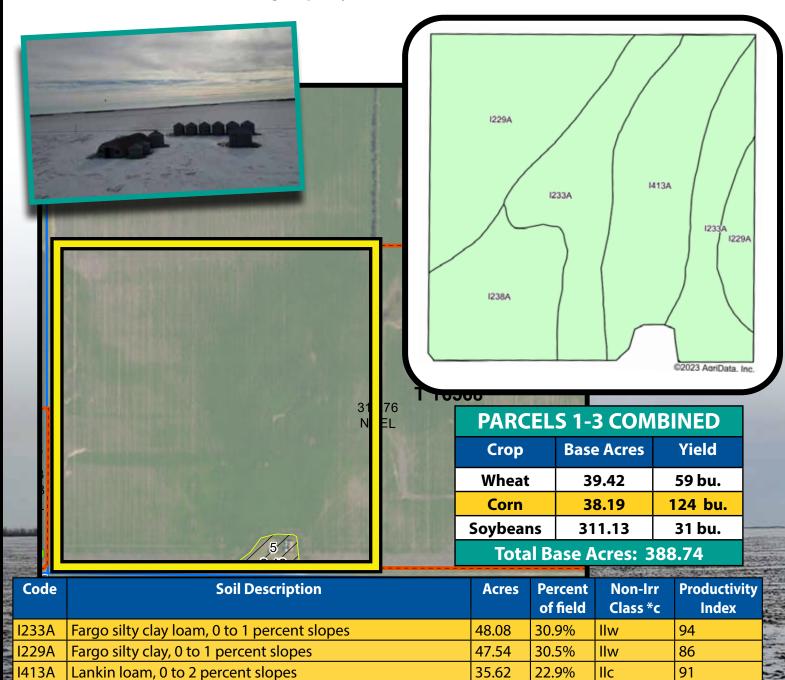

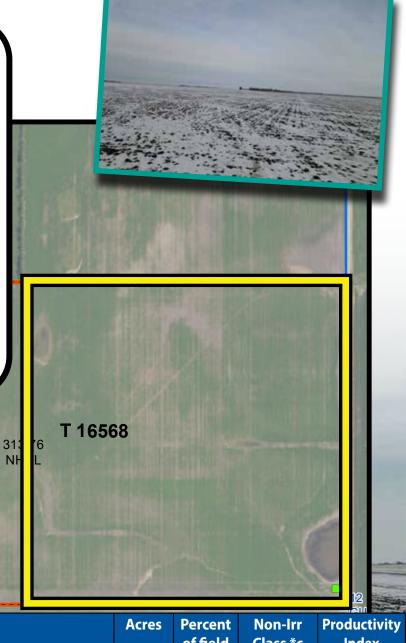

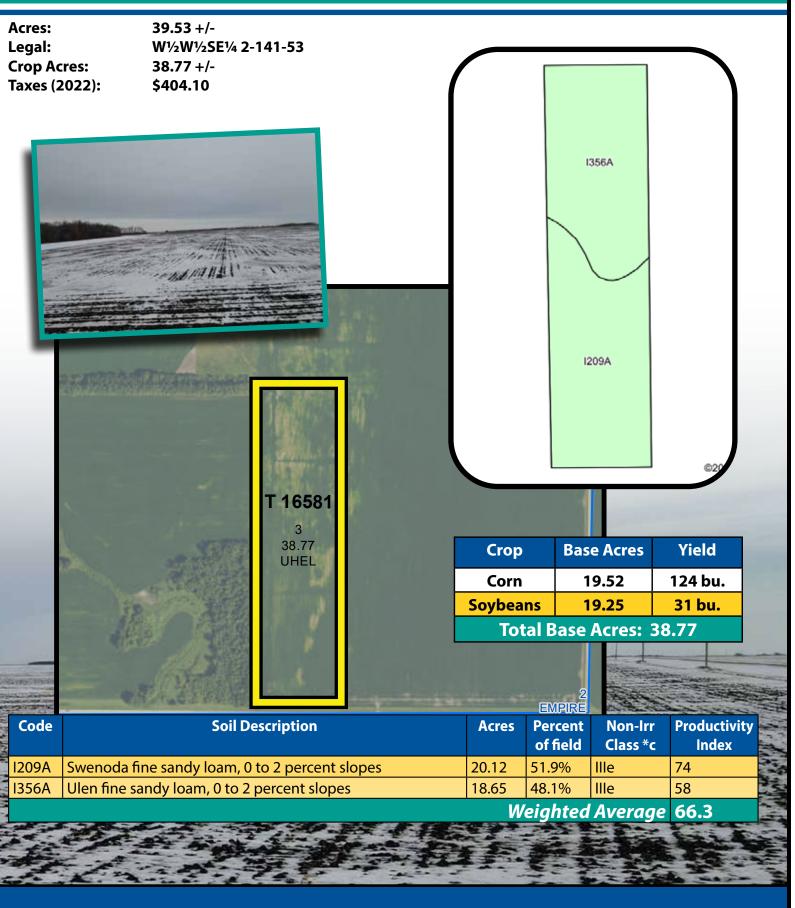

#### I. Terms and Conditions of Auction
