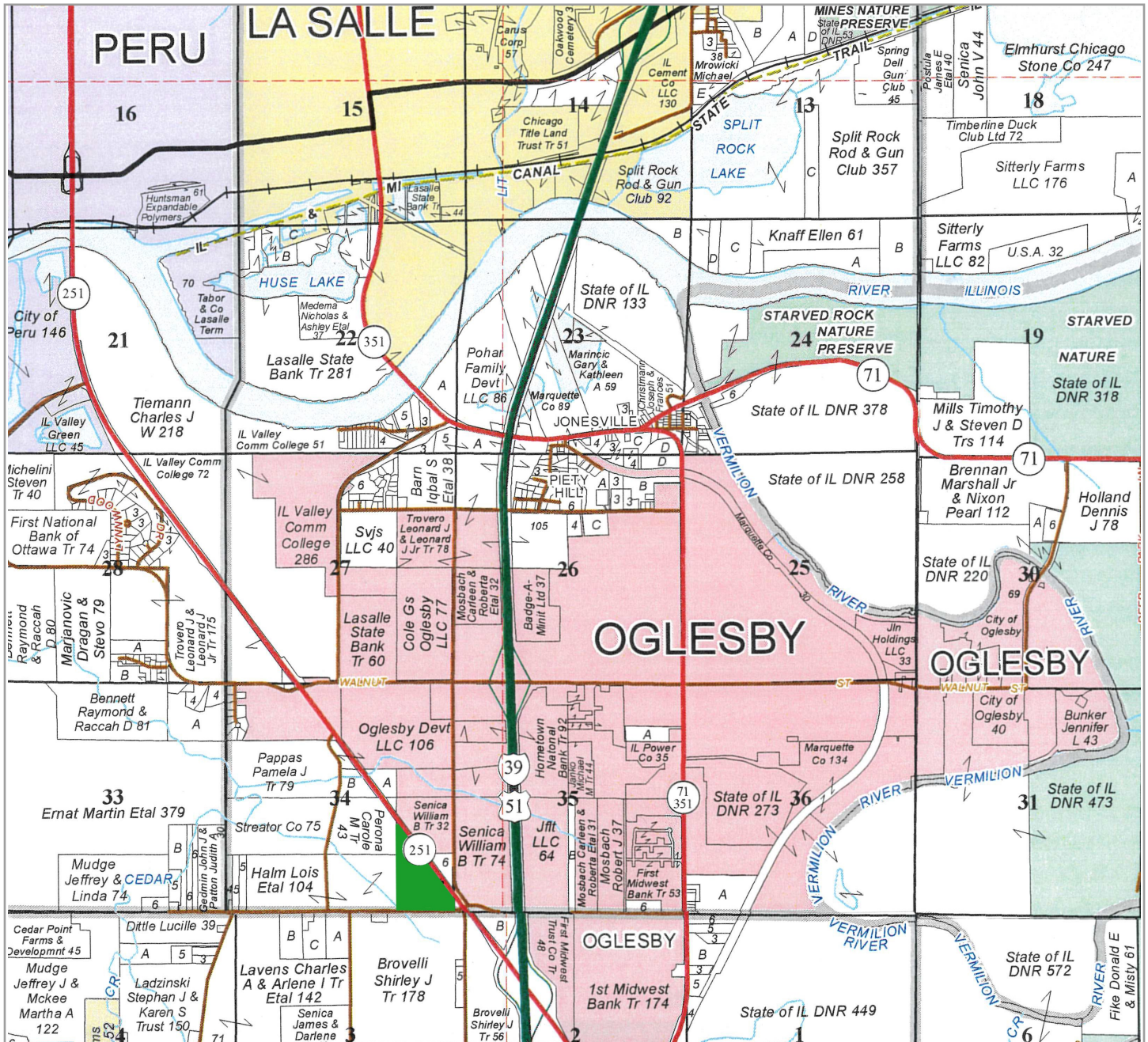

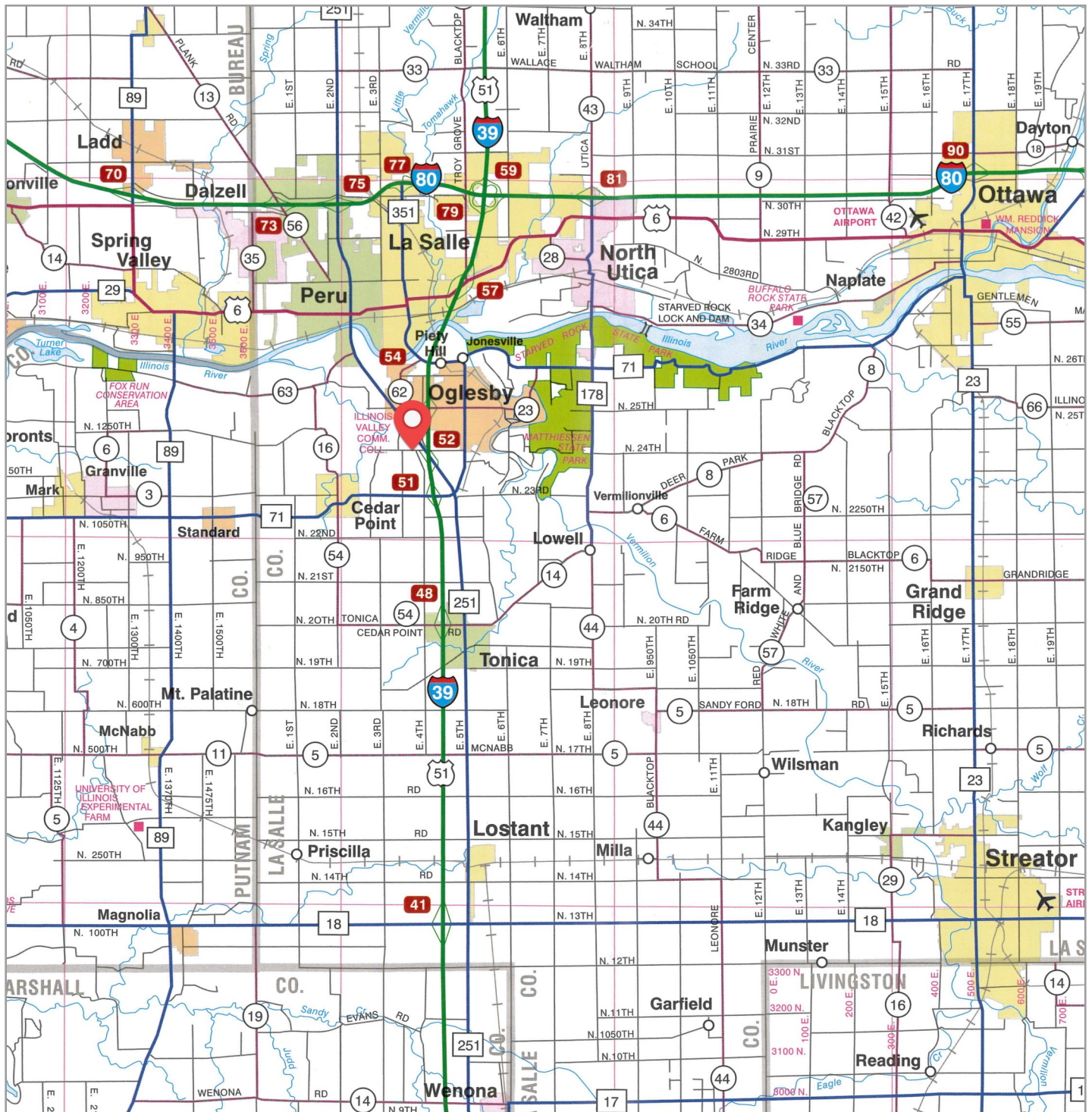
Plat Map

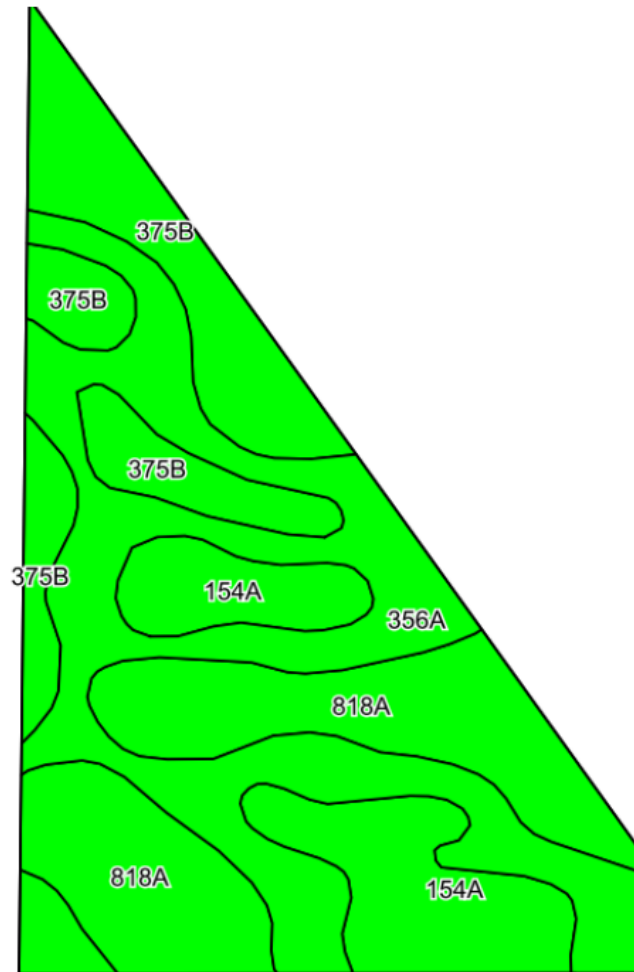
