COMMENCE AT THE SOUTHEAST CORNER OF SAID SECTION 13, SAID CORNER BEING A 4" X 4" CONCRETE MONUMENT (UNMARKED); THENCE NORTH 86° 56' 57" WEST ALONG THE SOUTH LINE OF THE SOUTHEAST QUARTER OF SECTION 13 FOR 2638.34 TO THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 13, SAID CORNER BEING A ½" CAPPED IRON ROD (RLS 1748); THENCE NORTH 86° 57' 49" WEST ALONG THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SECTION 14 FOR 1323.72 FEET; THENCE NORTH 87° 08' 33" WEST ALONG THE SOUTH LINE OF SECTION 14 FOR 1323.72 FEET; THENCE NORTH 2° 44' 01" EAST FOR 2714.45 FEET FOR A POINT OF BEGINNING; THENCE CONTINUE N 2° 44' 01" EAST FOR 688.01 FEET; THENCE SOUTH 87° 18' 23" EAST FOR 1323.39 FEET; THENCE SOUTH 2° 45' 42" WEST FOR 179.13 FEET TO THE POINT OF CURVE OF A CIRCULAR CURVE BEING CONCAVE TO THE WEST HAVING A RADIUS OF 6752.56 FEET AND A CENTRAL ANGLE OF 1° 41' 19" (CH = 199.01', CH. BRG = S 3° 36' 20" W); THENCE RUN SOUTHERLY ALONG THE ARC OF SAID CURVE FOR 199.01 FEET TO THE POINT OF REVERSE CURVE OF A CIRCULAR CURVE BEING CONCAVE TO THE EAST HAVING A RADIUS OF 6790.62 FEET AND A CENTRAL ANGLE OF 1° 41' 44" (CH = 200.96', CH. BRG = S 3° 36' 00" W); THENCE RUN SOUTHERLY ALONG THE ARC OF SAID CURVE FOR 200.96 FEET TO THE POINT OF TANGENCY; THENCE SOUTH 2° 45' 07" WEST FOR 109.11 FEET; THENCE NORTH 87° 18' 01" WEST FOR 1317.20 FEET TO THE POINT OF BEGINNING. CONTAINING 20.86 ACRES MORE OR LESS.
