22.82 ACRES

These notes describe that certain 22.82 acres in the JAMES WILSON, TRUSTEE SURVEY, Abstract 1469, located in Leon County, Texas; being all of that 22.819 Acres contained in a Warranty Deed dated October 26, 1990 from James W. Wilson, Trustee to Charles D. Hallberg and recorded in Volume 780 Page 810 Leon County Official Records; this 22.82 acre tract is described more particularly as follows:

BEGINNING at the South corner of that 20.000 Acres(recorded in Volume 787 Page 240 LCOR and re-surveyed this date by the undersigned), same being the West corner of the 22.819 Acres in the Southwest line of a 60' wide access strip of 7.663 Acres (recorded in Volume 787 Page 240 LCOR) and now known as Private Road 4250; found a ½" steel rod (no cap) offset North 56°-41'-32" East 60.00 feet;

THENCE with the Southwest line of the 22.819 Acres, same being the Southwest line of said 60' wide access strip of 7.663 Acres (Private Road 4250), along an existing fence, as follows:

South 34°-05'-00" East	235.08 feet; found a 1" galvanized pipe at same; found a $\frac{1}{2}$ " steel rod (no cap) offset North 56°-23'- 32" East 60.00 feet;
South 33°-07'-57" East	369.99 feet to the South corner of the 22.819 Acres, same being the West corner of that 21.000 Acres (recorded in Volume 1832 Page 179 LCOR); found a ½" steel rod (no cap) offset North 56°-42'- 02" East 60.00 feet;

THENCE with the non-fenced Southeast line of the 22.819 Acres, same being the Northwest line of the 21.000 Acres, North 56°-42'-02" East a distance of 1,671.08 feet to the East corner of the 22.819 Acres, same being the North corner of the 21.000 Acres in the Southwest line of that "161.1 acres" (recorded in Volume 1580 Page 110 LCOR); found a ½" steel rod (no cap) at same;

THENCE with a line of the 22.819 Acres, same being the Southwest line of the "161.1 acres", North 32°-09'-58" West a distance of 370.31 feet to an exterior corner of the 22.819 Acres, same being the West corner of the "161.1 acres" and the South corner of that "53.70 acres" (recorded in Volume 1580 Page 106 LCOR); found an iron shaft at same; found a 15" Hickory marked X bearing North 03° East 19.1 feet;

THENCE with a line of the 22.819 Acres, same being a the Southwest line of the "53.70 acres", North 69°-42'-32" West a distance of 292.03 feet to North corner of the 22.819 Acres, samebeing the East corner of the 20.000 Acres; found a ½" steel rod at same at a fence corner;

THENCE with the non-fenced Northwest line of the 22.819 Acres, same being the Southeast line of the 20.000 Acres, South 56°-41'-32" West a distance of 1,507.21 feet to the PLACE OF BEGINNING.

Containing according to the dimensions herein stated, an area of 22.82 acres of land.
