

NOTICE TO PURCHASERS


The real property, described below, that you are about to purchase is located in HAYS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 2. The District has taxing authority separate from any other taxing authority, and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds. The most recent rate of tax levied by the District, as of this date, on real property located in the District is \$0.865 on each \$100 of assessed valuation. The total amount of bonds excluding refunding bonds and any bonds or any portion of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by voters and which have been or may, at this date, be issued is \$91,255,000, and the aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the district and payable in whole or part from property taxes is \$45,980,000.

The District is located in whole or in part in the extraterritorial jurisdiction of the City of Dripping Springs. By law, a district located in the extraterritorial jurisdiction of a municipality may be annexed without the consent of the district or the voters of the District. When a district is annexed, the district is dissolved.


The purpose of this District is to provide water, sewer, drainage, flood control facilities and services and roads within the District through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility and road facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the District.
