TIEMAN SURVEY 17 Abstract 1505, and JO SWINDLE SURVEY 17 Abstract 1527. Situated approx. 3.7 miles Southeast of Priddy, Mills County, Texas. Said 248.64 Acre tract of land is more particularly described by metes and bounds as follows:

THENCE N 72° 29' 07" W, (Adjoiner/Deed Call S 71° 30' 41" E ~ 1,131.74' – Doc. #1201782, R.R.M.C.T.) with the North line of said 168.393 acre tract, for the South line of said 418.55 acre tract, as fenced, a distance of 1,131.53 feet to a ½ inch iron rod (Control Monument) found, for the Northwest line of said 168.393 acre tract, for the Northeast corner of the Alton Drueckhammer Tract same being the Northeast corner of C.F. NOACK SURVEY 2 Abstract 1507, for a deflection corner of said 418.55 acre tract, for a deflection corner of this tract;

N 25° 28' 49" E, a distance of 17.06 feet to a 2 inch steel fence corner post found, for a deflection corner of this tract;

N 22° 03' 52" E, a distance of 271.58 feet to a 2 inch steel fence corner post found, for an inner corner of this tract;

N 70° 27' 25" W, a distance of 20.20 feet to a 2 inch steel fence corner post found, for the Southeast corner of a called 157.88 acre tract designated as Second Tract as recorded in Document #1809198, Official Public Records. Mills County, Texas, for an inner corner of said 418.55 acre tract, for an upper Southwest corner of this tract;

THENCE N 17° 08' 37" E, (Adjoiner/Deed Call S 18° 13' 42" W ~ 3,080.39' - Doc. #1809198, R.R.M.C.T.) for the East line of said 157.88 acre tract, for the upper West line of said 418.55 acre tract, a distance of 2,999.02 feet to a 2 inch steel fence corner post found, taken for a common deflection corner of 157.55 acre tract and said 418.55 acre tract, for a South corner of said County Road 265, as fenced, for a deflection corner of this tract;

THENCE N 17° 04' 07' E, (Adjoiner/Deed Call S 18° 13' 42" W ~ 3,080.39' – Doc. #1809198, R.R.M.C.T.) continuing with the common East line of said 157.88 acre tract and the upper West line of said 418.55 acre tract, at 23.76 feet pass a Point, for the lower Northeast corner of said 157.88 acre tract opposite of remnants of an old cattle guard same being the old corner of said County Road 265, continuing with the East R.O.W. line of said Co. Rd. 265, in all a distance of 34.01 feet to the **POINT OF BEGINNING**, and containing 248.64 acres of land, more or less.
