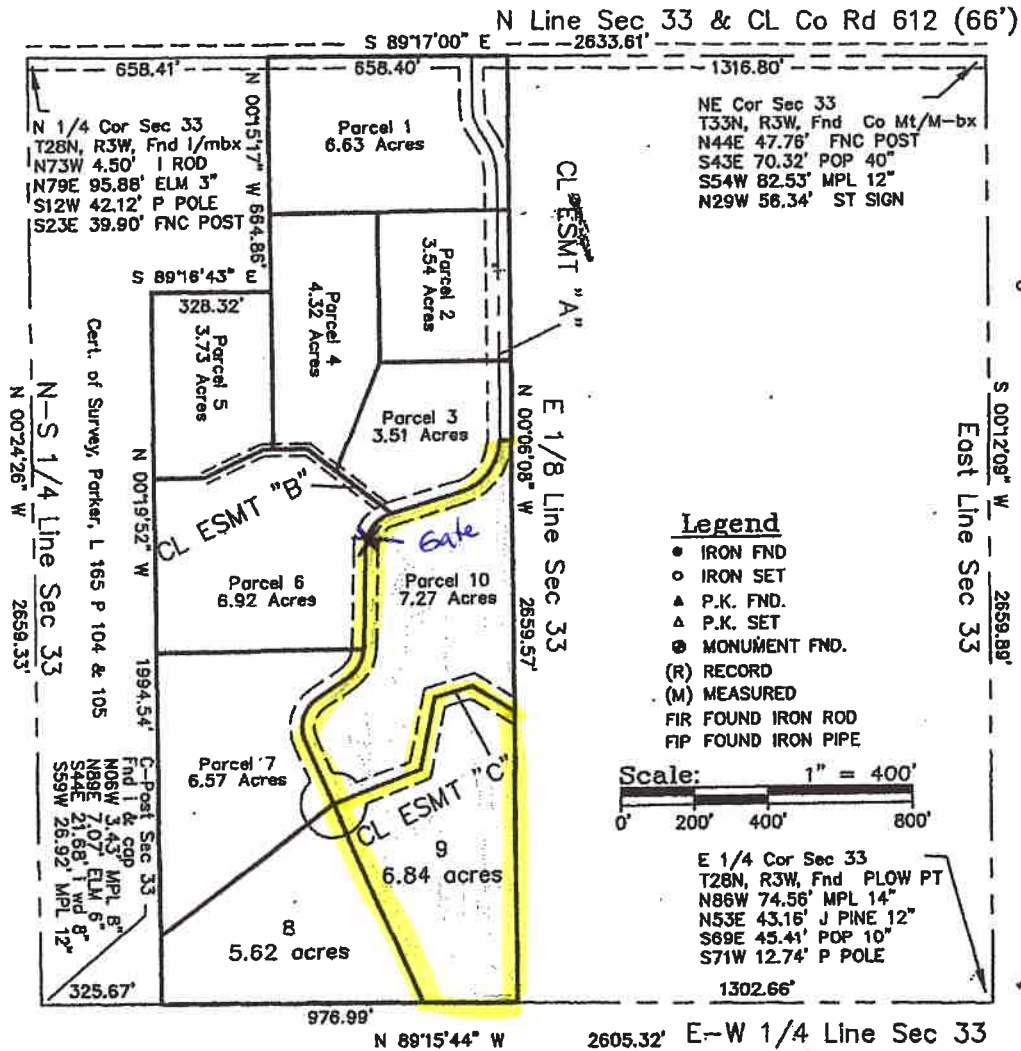

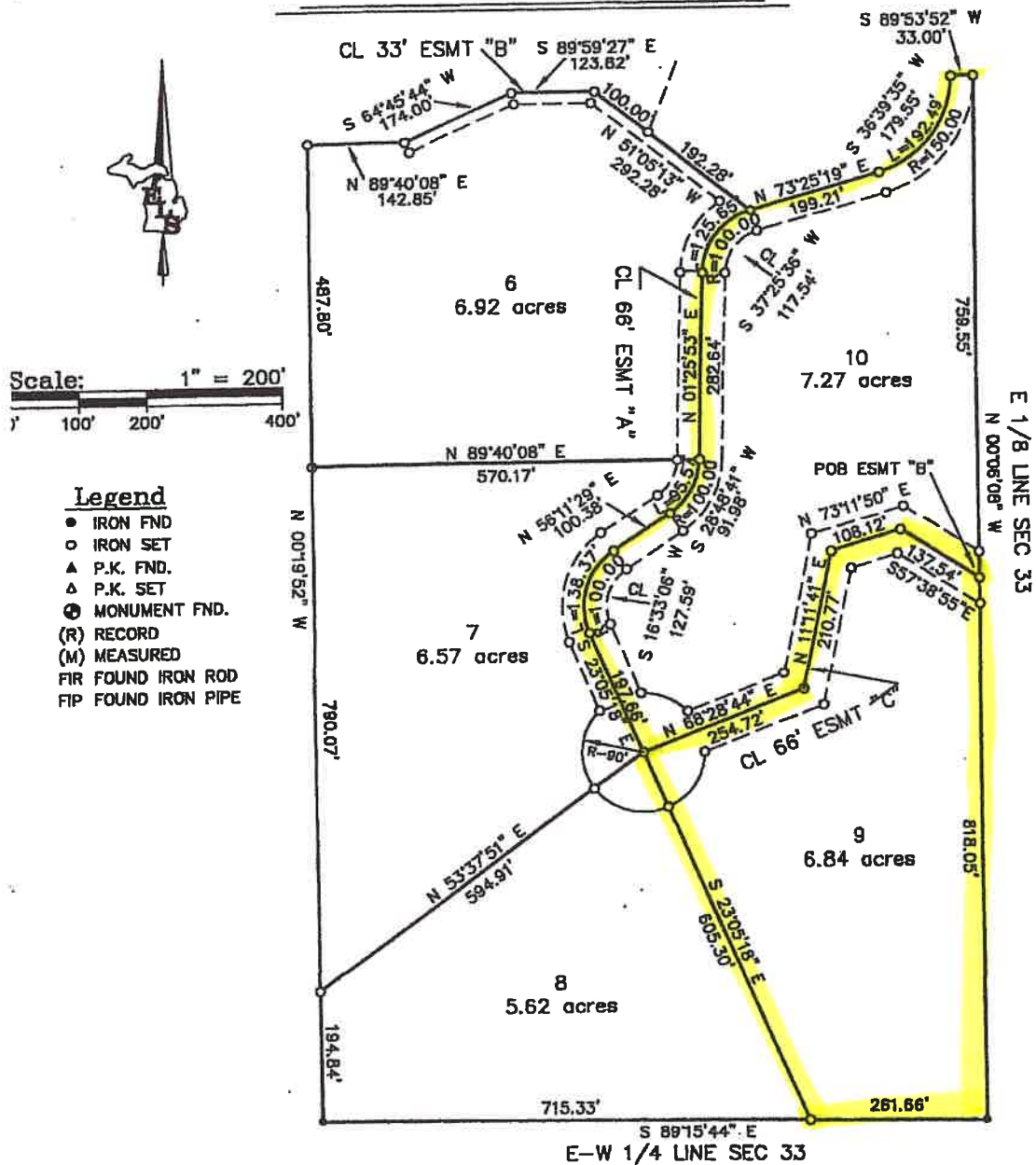

PARCEL 9;

A parcel of land situated in Maple Forest Township, Crawford County, Michigan, and more fully described as follows:

That part of the Northeast 1/4 of Section 33, Town 28 North, Range 3 West, described as: Commencing at the North 1/4 corner of said section 33; thence South 89°17'00" East along the North line of said section and the centerline of 612 Road 1316.81 feet to a point on the East 1/8 line of said section; thence South 00°06'08" East along said 1/8 line 1851.53 feet to the point of beginning; thence continuing South 00°06'08" East along said 1/8 line 818.05 feet to a point on the East and West 1/4 line of said section; thence North 89°15'44" West along said 1/4 line 261.86 feet; thence North 23°05'18" West 605.30 feet; thence North 68°28'44" East 254.72 feet; thence North 11°11'41" East 210.77 feet; thence North 73°11'50" East 108.12 feet; thence South 57°38'55" East 137.54 feet to the point of beginning; and containing 6.84 acres of land.

Subject to and together with easement's "A" and "C" as described below.

That part of the Northeast 1/4 of Section 33, Town 28 North, Range 3 West, described as: Commencing at the North 1/4 corner of said section 33; thence South 89°17'00" East along the North line of said section and the centerline of 612 Road 1316.81 feet to a point on the East 1/8 line of said section; thence South 00°06'08" East along said 1/8 line 1091.98 feet to the point of beginning; thence continuing South 00°06'08" East along said 1/8 line 759.55 feet; thence North 57°38'55" West 137.54 feet; thence South 73°11'50" West 108.12 feet; thence South 11°11'41" West 210.77 feet; thence South 68°28'44" West 254.72 feet; thence North 23°05'18" West 197.66 feet; thence 138.37 feet along the arc of a 100.00 feet radius curve to the right whose long chord bears North 16°33'06" East 127.59 feet; thence North 56°11'29" East 100.38 feet; thence 95.57 feet along the arc of a 100.00 feet radius curve to the left whose long chord bears North 28°48'41" East 91.98 feet; thence North 01°25'53" East 282.64 feet; thence 125.65 feet along the arc of a 100.00 feet radius curve to the right whose long chord bears North 37°25'36" East 117.54 feet; thence North 73°25'19" East 199.21 feet; thence 192.49 feet along the arc of a 150.00 feet radius curve to the left whose long chord bears North 36°39'35" East 179.55 feet; thence North 89°53'52" East 33.00 feet to the point of beginning; and containing 7.27 acres of land.
