## Tract IV

Hord, and Michelle Thoroughman, D.B. 353 Pg. 403 Exhibit A, Exhibit C Parcel 1 and new corner to Exhibit B; thence leaving Hord Exhibit A, Hord Exhibit C Parcel 1 and said road, with a new division line of Hord Exhibit B, S 27°54'36" W a distance of 88.82' to a point in the center of a branch of Cabin Creek; thence up the branch S 02°00'05" W a distance of 63.91' to point; thence up the water fall S 17°06'35" E a distance of 104.96' to a point in the center of the branch; thence leaving the branch, S 18°33'23" E a distance of 51.99' to an iron pin set on the east side of the branch; thence around the base of the hill, S 14°44'50" E a distance of 310.96' to an iron pin set at a 22" Maple; thence S 06°34'41" W a distance of 387.61' to an iron pin set at a fence post new corner to Hord Exhibit B; thence following a fence,  $N 77^{\circ}00'32"$  W a distance of 42.27' to a fence post; thence  $N 82^{\circ}55'49"$  W a distance of 73.22' to an iron pin set at a fence post corner; thence leaving the fence and crossing the branch, N 70°16'13" W a distance of 43.19' to a mag nail found in the approximate center line of a concrete bridge; thence with the centerline of Springdale Road, N 01°45'29" E a distance of 252.99' to a mag nail found; thence N 04°19'22" E a distance of 148.67' to a mag nail found; thence N 05°52'56" E a distance of 187.21' to a mag nail found; thence N 03°13'00" W a distance of 215.26' to a mag nail found; thence N 06°17'02" E a distance of 169.27' to a mag nail found at the junction of Kentucky Highway 984 (A.K.A. Springdale Road and Cabin Creek Road); thence leaving Springdale Road and with the centerline of Cabin Creek Road, S 70°07'14" E a distance of 76.07' to the point of beginning containing 2.781 acres as surveyed by Timothy D. Pugh, PLS #4047 in April 2023.
