KANSAS DOMESTIC ANIMAL LIABILITY ACT WARNING

"Under Kansas law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from inherent risks of domestic animal activities, pursuant to K.S.A. §60-4001 through K.S.A. §60-4004. You are assuming the risk of participating in this domestic animal activity.

Inherent risks of domestic animal activities include, but shall not be limited to:

- (1) The propensity of a domesticated animal to behave in ways, i.e. running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them;
- (2) The unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons, or other animals;
- (3) Certain hazards such as surface or subsurface conditions;
- (4) Collisions with other domestic animals or objects; and
- (5) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability." K.S.A. § 60-4002 (1994)

- Slipping, falling, or otherwise being injured in the barn, stalls, or on the grounds, which can be slippery, muddy, wet, or contain or present other hazards.

Participant hereby specifically forever waives and releases Jeffrey J. Dreiling, Jennifer L. Dreiling, Silver Star Stables, LLC, and/or McCurdy Real Estate & auction, LLC from any liability or injury arising out of the inherent risks from riding, working or participating n a stable environment and/or with horses, as well as from the active negligence of Jeffrey J. Dreiling, Jennifer L. Dreiling, Silver Star Stables, LLC and/or McCurdy Real Estate & Auction, LLC.

By signing this Agreement, Participant hereby acknowledges that although there may be some supervision during their time spent at Silver Star Stables, LLC, there will not be a nurse or physician, or other health care provider, on the premises and Silver Star Stables, LLC, Jeffrey J. Dreiling, Jennifer L. Dreiling and/or McCurdy Real Estate & Auction, LLC, bears no responsibility for Participant's health or medical care.

Participant agrees to indemnify, save and hold harmless Silver Star Stables, LLC, Jeffrey J. Dreiling, Jennifer L. Dreiling and/or McCurdy Real Estate & Auction, LLC from and against any loss, liability, damages, attorneys' fees, or costs that they may incur arising out of or in any way connected with either their presence or participation at Silver Star Stables, LLC or any acts or omissions of Silver Star Stables, LLC, Jeffrey J.
