


## DEED OF RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS THAT Gordon Baxter, Inc., the owner of 116.27 acres, more or less, located in Section 33, Township 50 North, Range 2 East of the 5th P.M., Lincoln County, Missouri does hereby declare and impose the following restrictions upon all tracts of land:

1. All house or dwelling plans shall be approved by the developer or by his heirs, assigns or successors to insure an attractive and desirable area.
2. Mobile homes older than seven years must be approved by the developer. Not more than one mobile home allowed per 2 acre tract. Minimum lot size allowed is 21x50 acres.
3. No tents, shacks, garages, barns or other outbuildings shall be erected without the approval of the developer.
4. No non-operating or unlicensed automobile, truck or other vehicle shall be allowed on any tract or roadway at any time.
5. All obnoxious pursuits including junk yards, automobile or motorcycle racing, gun or shooting clubs, food processing, slaughterhouses, etc. are prohibited.
6. An approved septic tank must be installed. Outdoor toilet facilities are prohibited.
7. No hugs allowed.
8. No tract shall be used as a dumping ground for rubbish, trashy garbage or other waste.
9. Road maintenance shall be at the expense of the buyers and shall be on a pro-rated basis among all property owners.
10. Said premises shall not be used for any unlawful purposes or for any purpose that will injure the reputation of the area or the peaceful enjoyment of others.


The restrictions imposed upon this tract of land may not be changed without the consent of all owners of any tract located within the 116.27 acres, more or less.




