#### PETITION TO EXTEND RESTRICTIONS OF WOODCREEK ESTATES

This petition is being circulated among the owners of property in WOODCREEK ESTATES for the purpose of EXTENDING THE TERM of restrictions applicable to such subdivision. The DECLARATION OF COVENANTS & RESTRICTIONS for such subdivision is recorded in VOLUME 1039, PAGE 409, REAL RECORDS, VAN ZANDT COUNTY, TEXAS. The restrictions sought to be extended are set forth in such record.

Code Ann. § 201.009(b)(4) before one year after the date on which the owner receives actual notice of the filing of this petition.
