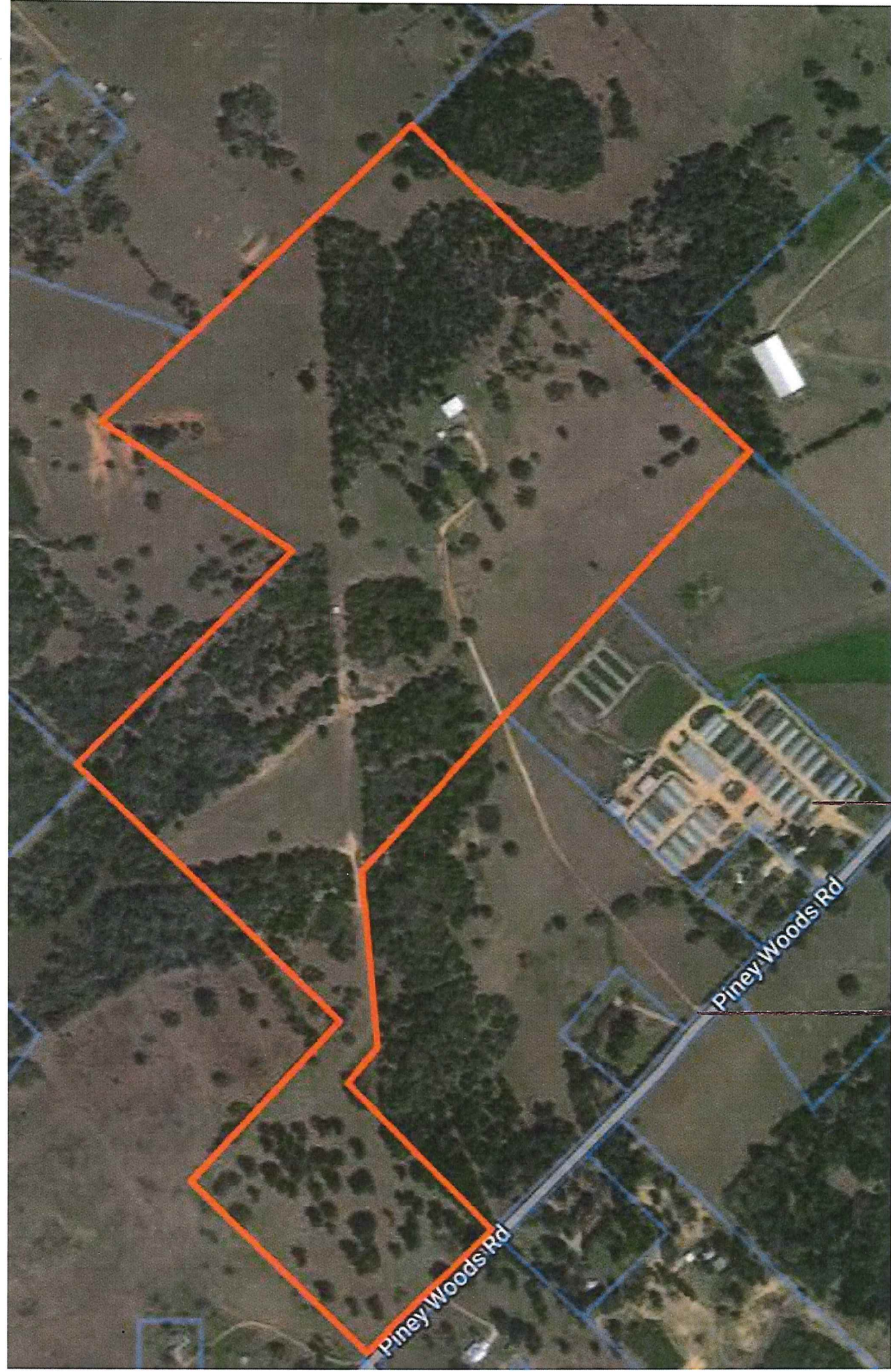

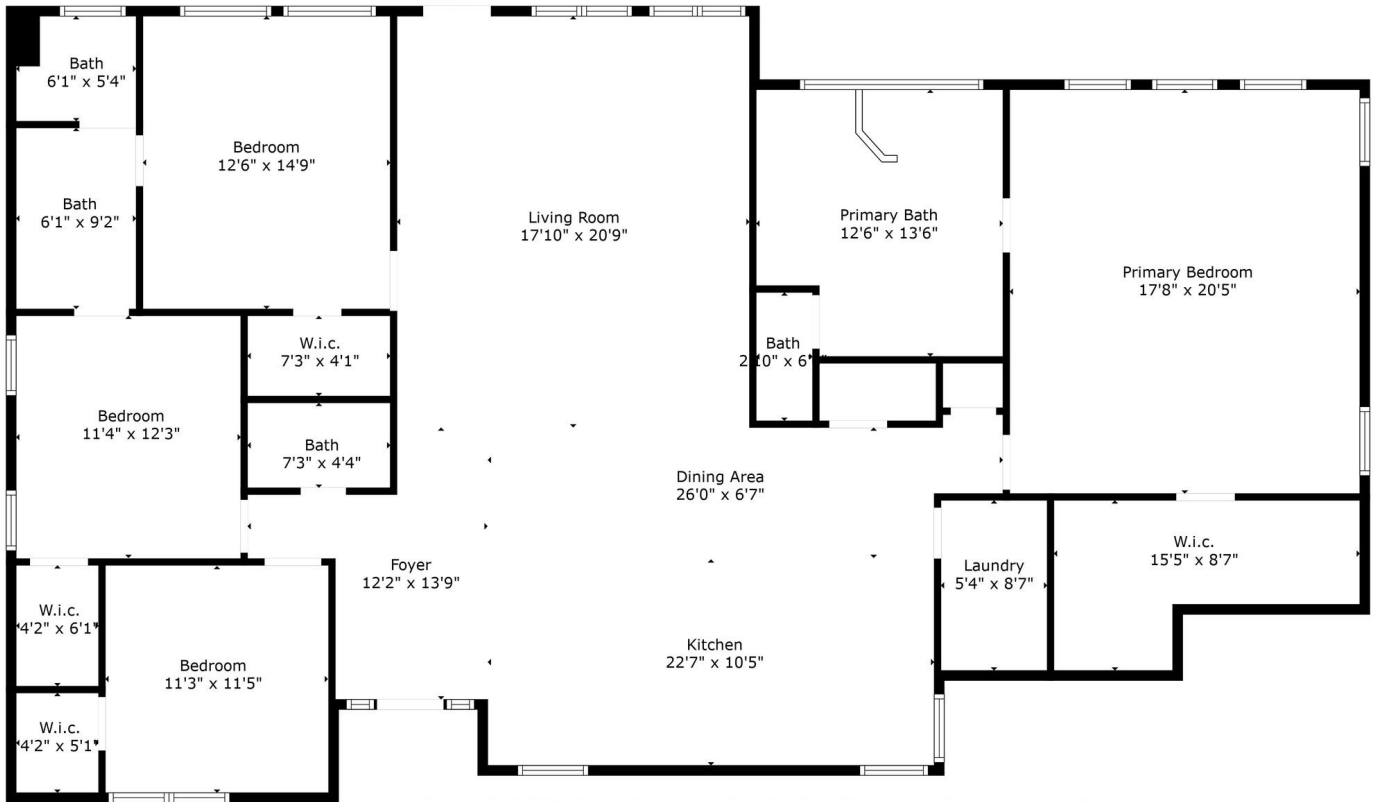

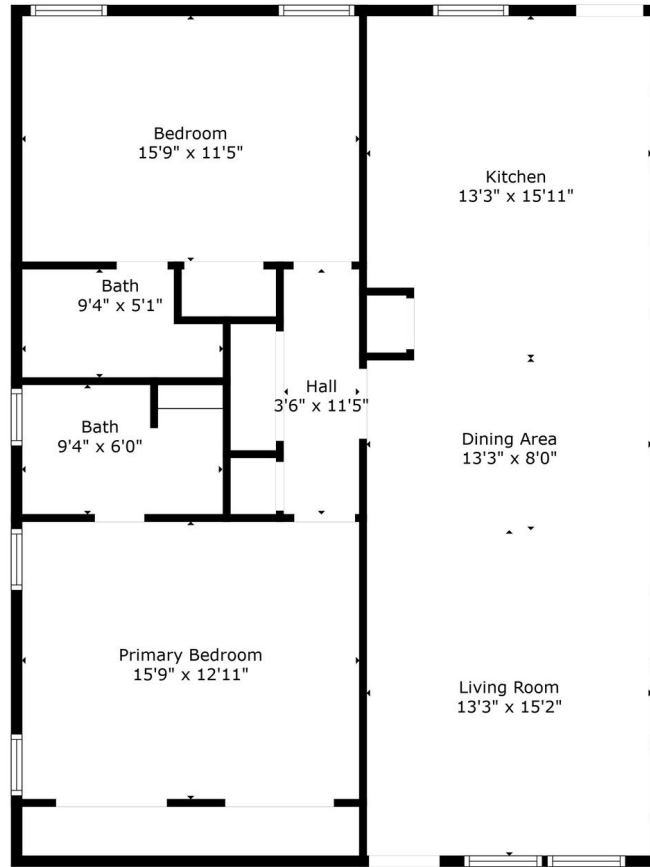

FLOORPLAN



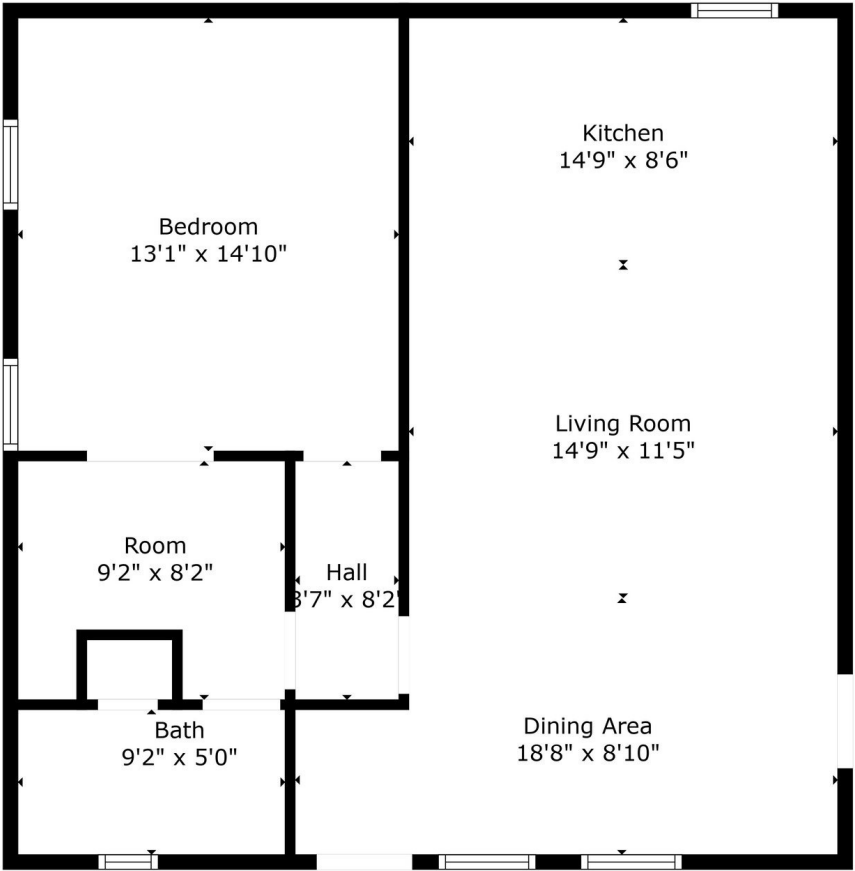
