General Information

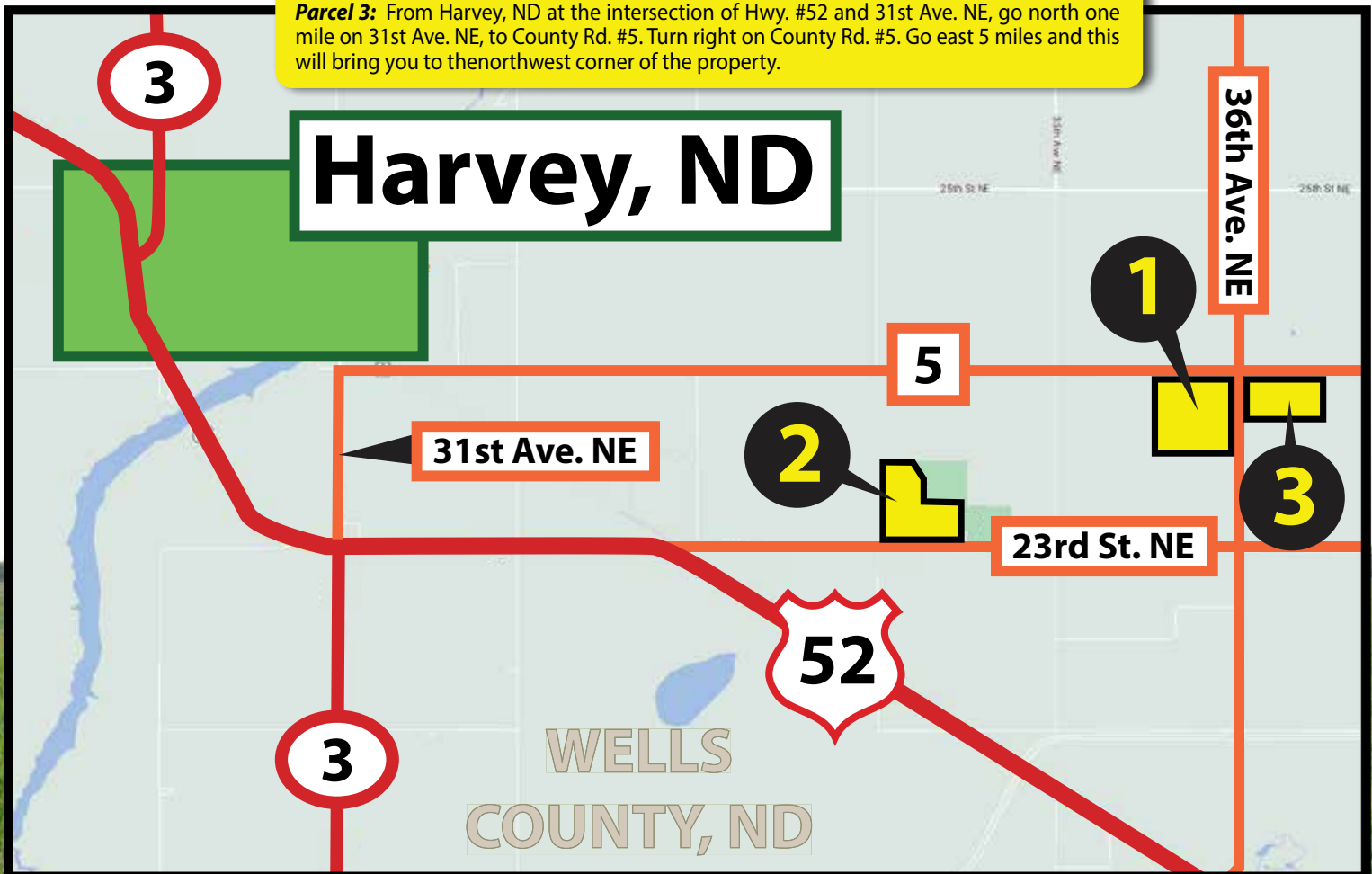

Driving Directions

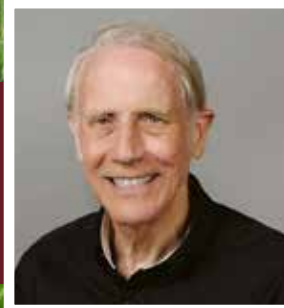

Parcel 2: From Harvey, ND proceed east on Hwy. #52 for 2 miles. Then 1 more mile east on 23rd St. NE and this will bring you to the southwest corner of the property.

Parcel 3: From Harvey, ND at the intersection of Hwy. #52 and 31st Ave. NE, go north one mile on 31st Ave. NE, to County Rd. #5. Turn right on County Rd. #5. Go east 5 miles and this will bring you to the northwest corner of the property.

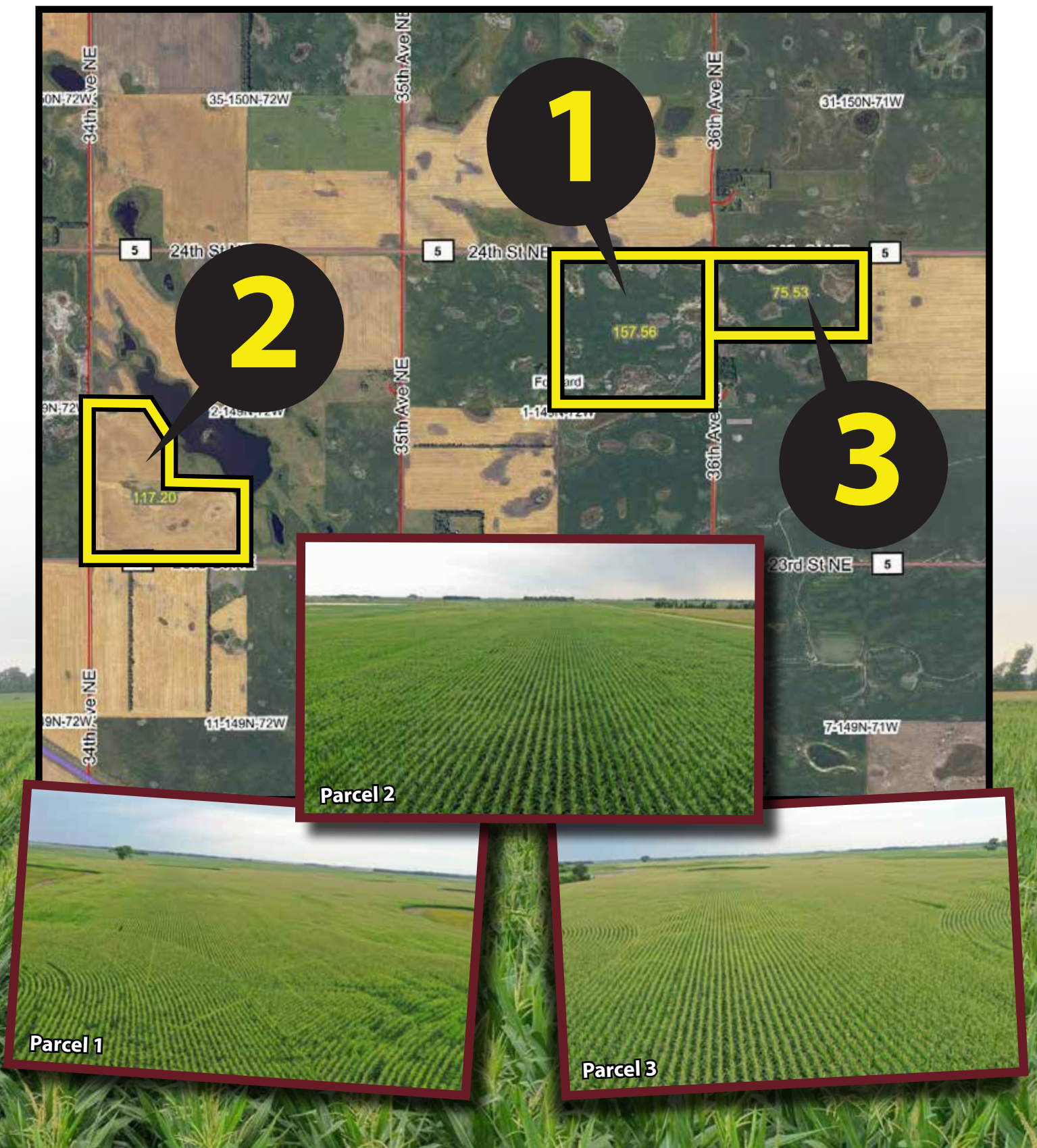

Terms & Conditions

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A. II. Bidding Procedures

All bidding is open to the public. You need only to raise your hand and shout out your bid, or instruct any of the ring men to do so on your behalf. Anyone who wishes to bid must first register to obtain a bidder's card at the registration desk.

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.
