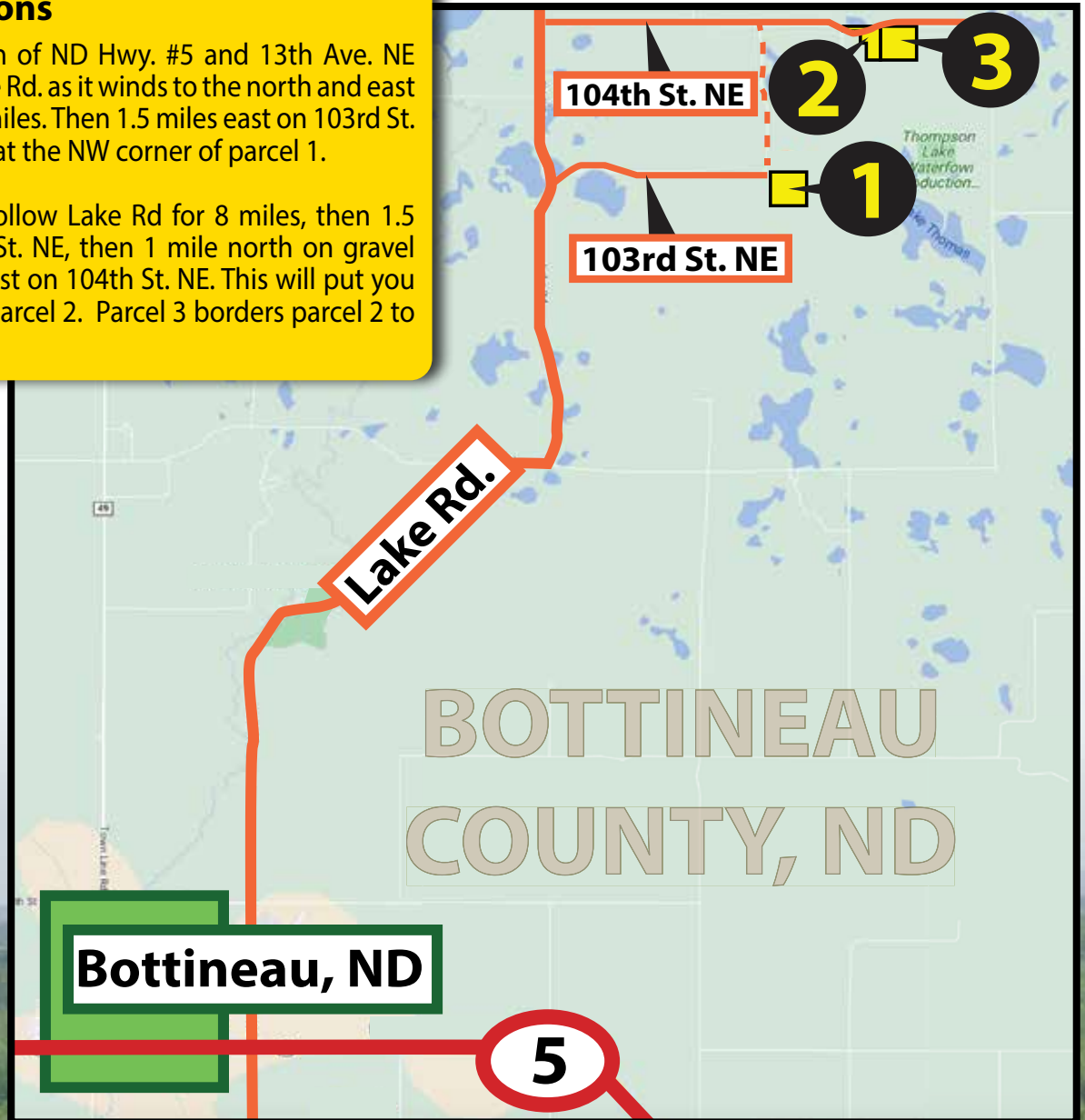
General Information

Driving Directions

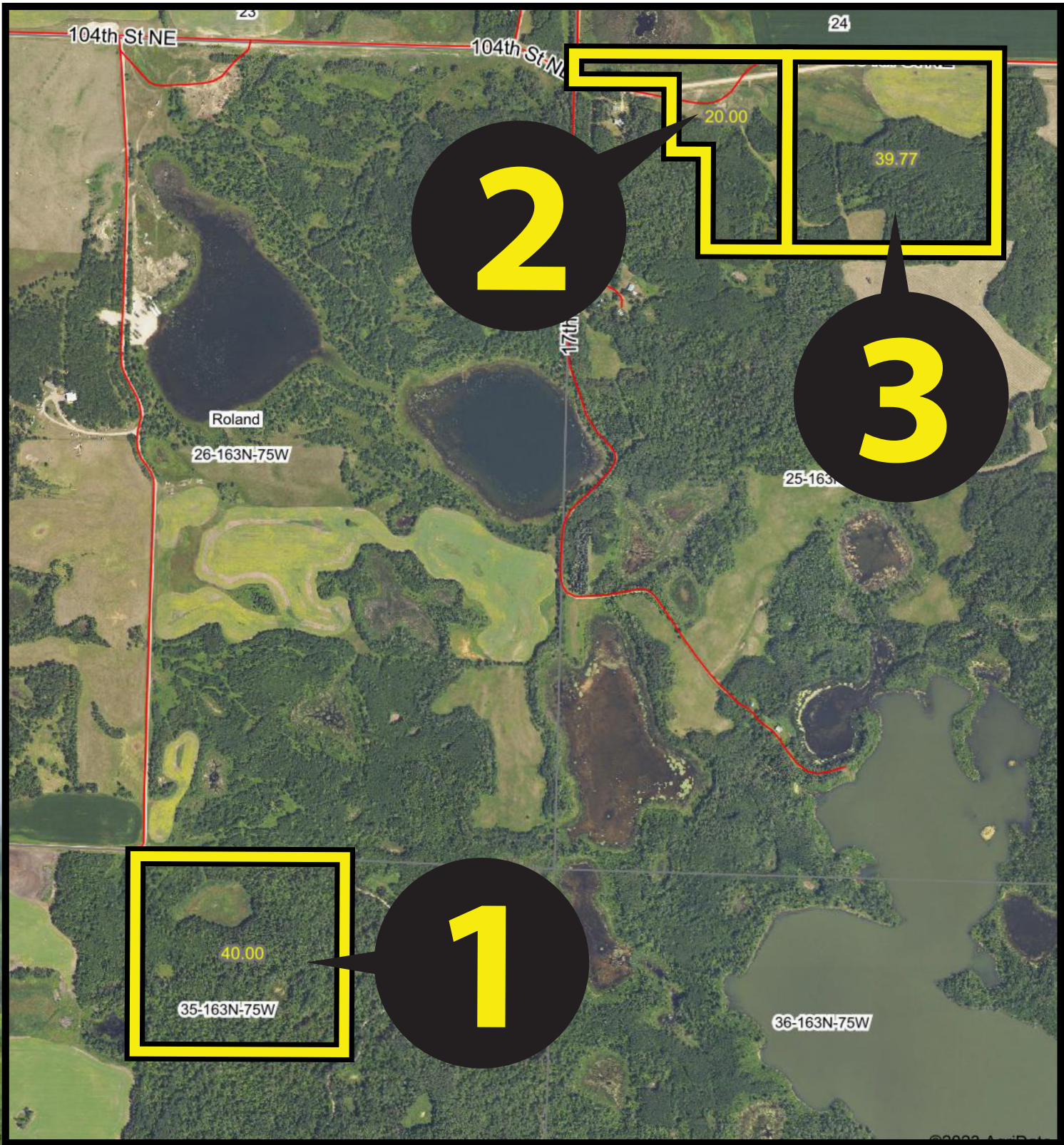
From the intersection of ND Hwy. #5 and 13th Ave. NE (Lake Rd.), follow Lake Rd. as it winds to the north and east for approximately 8 miles. Then 1.5 miles east on 103rd St. NE. This will put you at the NW corner of parcel 1.

For parcel 2 and 3, follow Lake Rd for 8 miles, then 1.5 miles east on 103rd St. NE, then 1 mile north on gravel road, then .6 miles east on 104th St. NE. This will put you at the NW corner of parcel 2. Parcel 3 borders parcel 2 to the east.

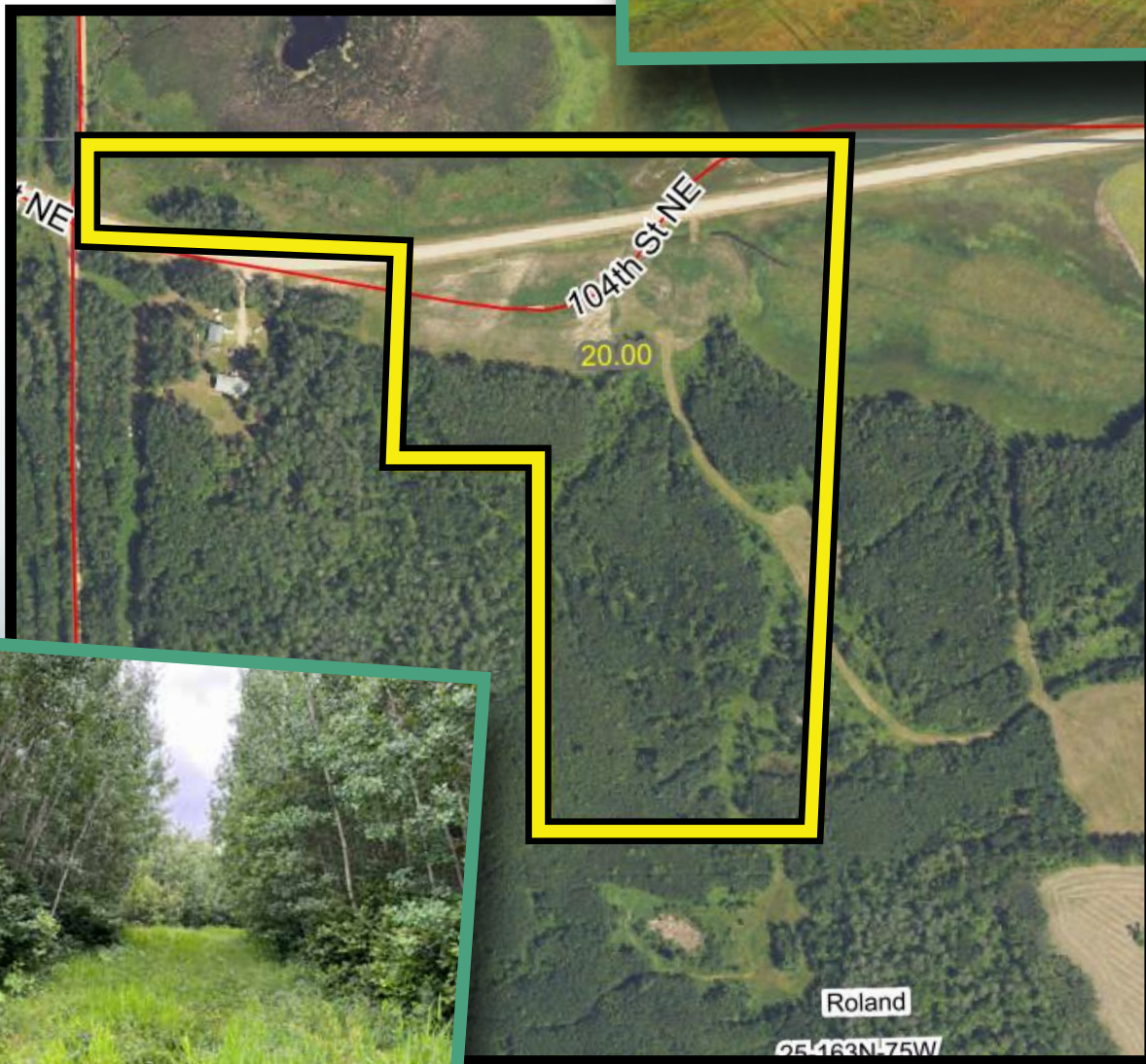

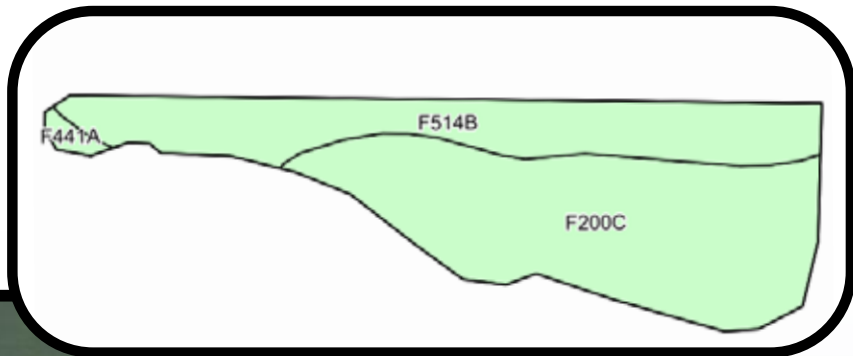

Terms & Conditions

I. Terms and Conditions of Auction

A. II. Bidding Procedures

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area
