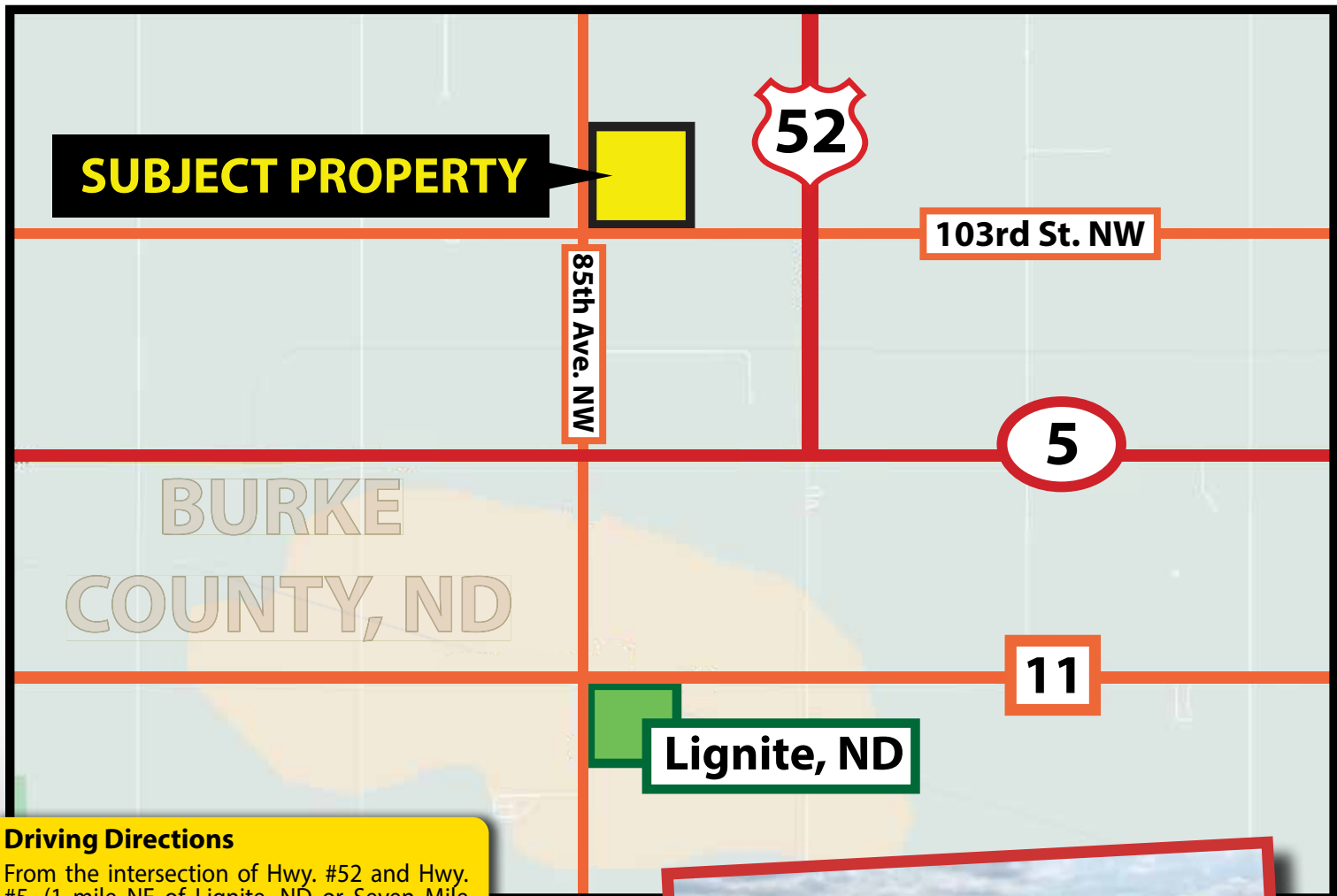

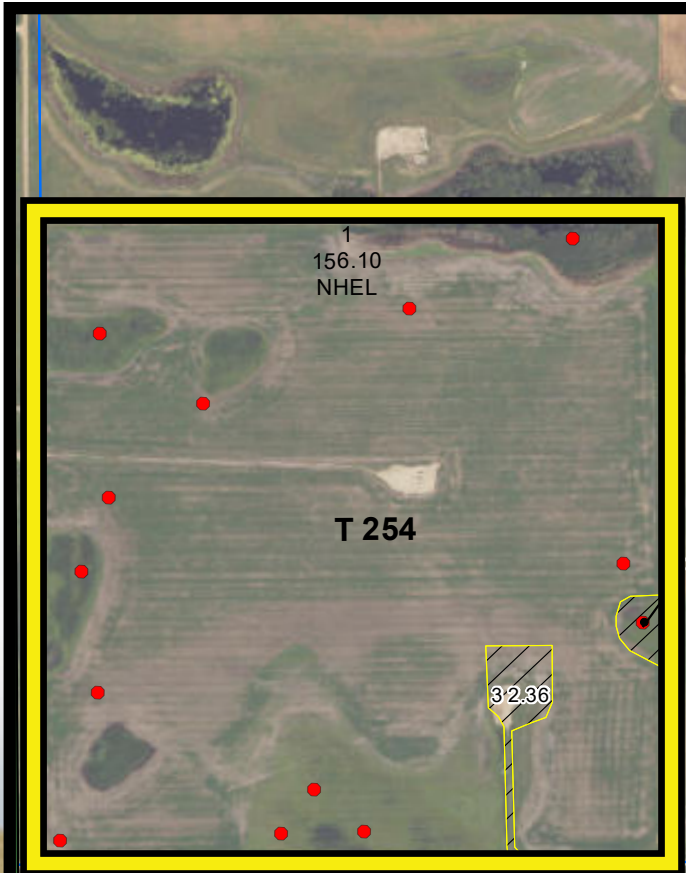
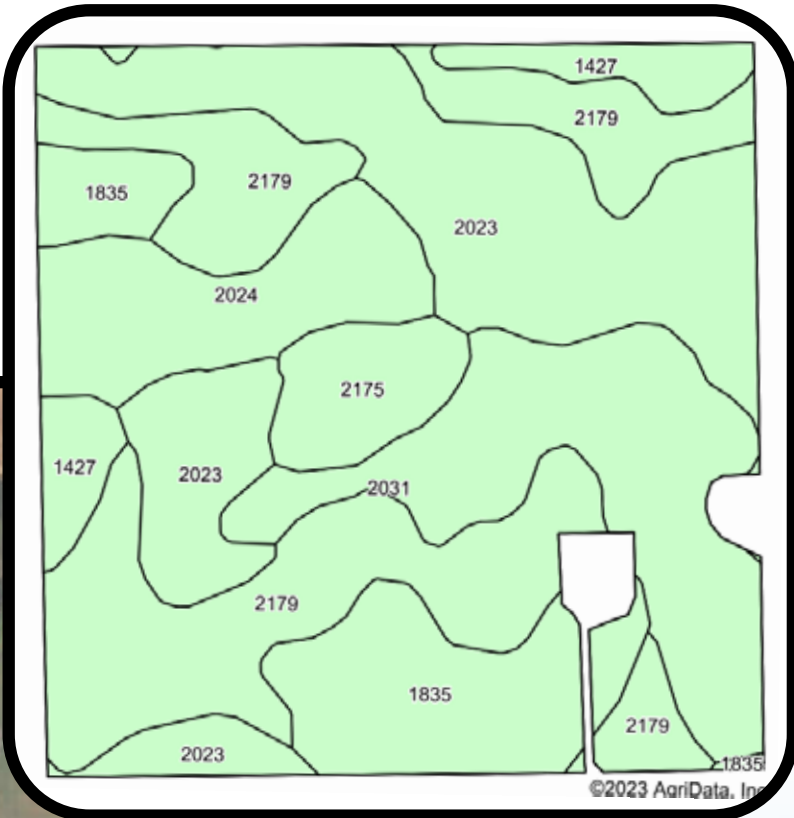

Terms & Conditions

I. Terms and Conditions of Auction

A.
