THENCE, South 11°33'15" East, coincident with the east right of way line of said Firefly Road and the west line of said 30 foot strip, a distance of 33.42 feet to an iron rod found for the southwest corner of said 30 foot strip, said point being the northwest corner of said 167.11 acre tract, this point being the **POINT OF BEGINNING** and having Grid Coordinates of N(Y) 10306470.160, E(X) 3118668.716, United States State Plane Coordinate System, Texas Central Zone 4203, NAD83, and for the northwest corner of this herein described tract;
