BEGINNING AT THE CORNER COMMON TO SECTIONS 5, 6, 7, & 8; THENCE ALONG THE LINE BETWEEN SECTIONS 6 & 7, N89°07'48"W A DISTANCE OF 1313.46' TO AN IRON ROD SET AT THE EAST 1/16 CORNER COMMON TO SAID SECTIONS;

THENCE ALONG THE EAST 1/16 LINE OF SECTION 6, N01°10'41"E A DISTANCE OF 2639.00' TO AN IRON ROD SET AT THE CENTER-EAST 1/16 CORNER; THENCE S88°39'54"E A DISTANCE OF 1293.13' TO AN IRON ROD SET AT THE NORTHERLY PROLONGATION OF A FENCE LINE;

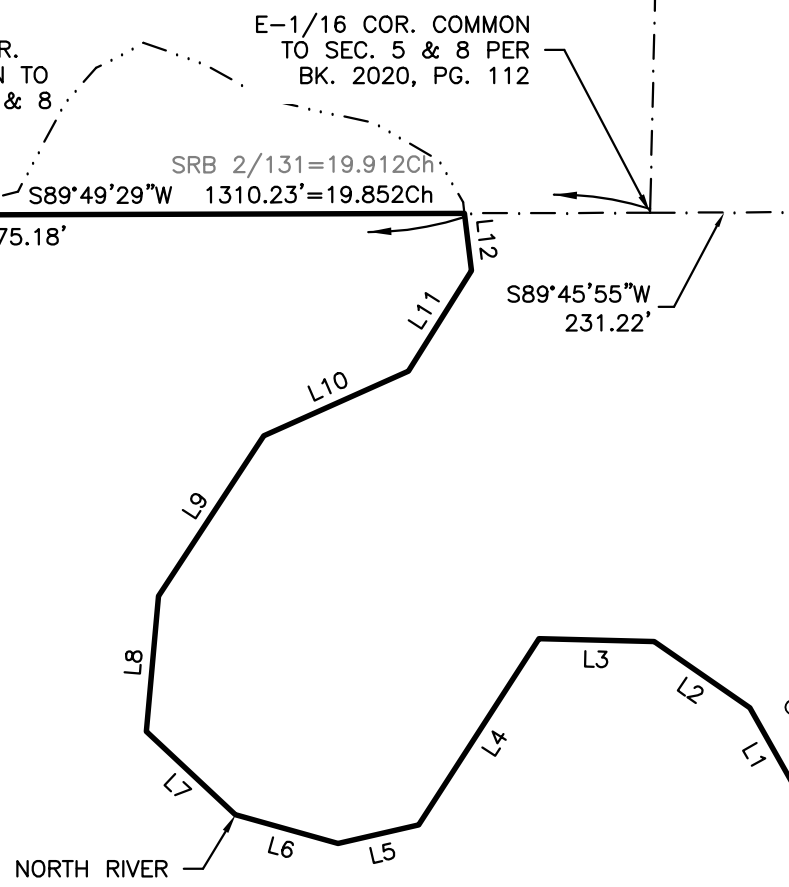

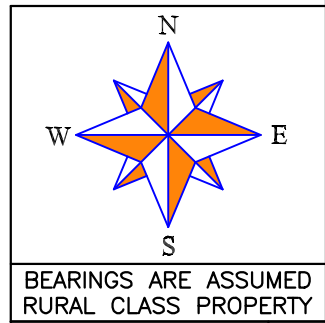
