TRACT 1 FOR CONNIE MANLY

STATE OF TEXAS COUNTY OF FAYETTE

This is the description of 13.216 acres of land located in the James Robinson League, Abstract No. 270 in Fayette County, Texas. These 13.216 acres are designated as Tract 1 of six tracts partitioned out of that same property described as a 20 acre Tract One, a 50 acre Tract Two, a 25.8 acre Tract Three, and a 32.5 acre Tract Four conveyed by Gilbert W. Marburger and wife, Hattie C. Marburger, to Janice Doehring, Pauline Klekar, Shirley Ryza, Delora Wagner, Gilbert R., Marburger and Connie Holder by deed dated March 14, 1988, recorded in Volume 767, Page 310 of the Fayette County Deed Records, SAVE AND EXCEPT that 50.00 acres conveyed by Janice Doehring, et al, to Donald E. Schmidt, et ux, by deed dated May 13, 1999, recorded in Volume 1063, Page 149 of the Fayette County Official Records. This 13.216 acre Tract 1 is more particularly described by metes and bounds as follows:

BEGINNING at a 3/8" iron rod found marking the northwest corner of the said 50 acre Tract Two, the same being the northeast corner of the Kenneth Wayne Kuchynka 41.95 acre tract described in Volume 962, Page 543 (Official Records), the same also being located in the south line of the Adriene Clark 161.75 acre tract described in Volume 1158, Page 32 (Official Records). This iron rod is also marking the northwest corner of this 13.216 acre Tract 1 being described, from which a fence corner post bears South 00 deg. 22 min. East 7.4 feet;

THENCE along the north line of the said 50 acre Tract Two, the same being the south line of the said Clark 161.75 acre tract, North 87 deg. 36 min. 02 sec. East 1376.54 feet to a 5/8" iron rod set for the northeast corner of the said 50 acre Tract Two, the same being the northwest corner of the Alvin L. Gosch 44 acre First Tract described in Volume 384, Page 76 (Deed Records), from which a 20 inch Post Oak tree bears South 52 deg. West 18.3 feet; a 16 inch Post Oak tree bears South 06 deg. West 15.6 feet; and a fence corner post bears South 15 deg. East 16.0 feet;

THENCE along the east line of the 50 acre Tract Two, the same being the west line of the said Gosch 44 acre tract, South 01 deg. 39 min. 32 sec. East 427.13 feet to a 5/8" iron rod set for the southeast corner of this 13.216 acre Tract 1 being described. This iron rod is also marking the northeast corner of that 13.216 acre Tract 3 surveyed this same day for Janice Doehring;

THENCE crossing the said 50 acre Tract Two, South 88 deg. 20 min. 00 sec. West, at 633.99 feet pass a 5/8" iron rod set for the northwest corner of the said 13.216 acre Tract 3, the same being the northeast corner of that 13.216 acre Tract 2 surveyed this day for Shirley Ryza, for a total distance of 1375.92 feet to a 5/8" iron rod set for the southwest corner of this 13.216 acre Tract 1 being described, the same being the northwest corner of the said Tract 2. This iron rod is located in the west line of the 50 acre Tract Two and the east line of the aforesaid Kenneth Wayne Kuchynka 41.95 acre tract;

THENCE along said line, North 01 deg. 43 min. 48 sec. West 409.53 feet, to the PLACE OF BEGINNING containing within these metes and bounds 13.216 acres of land.

ROAD EASEMENT CENTERLINE

STATE OF TEXAS COUNTY OF PAYETTE

This is the description of a road easement centerline located in the James Robinson League, Abstract No/270 in Fayette County, Texas. This road easement crosses over that same property described as a 20 acre Tract One, a 50 acre Tract Two, a 25.8 acre Tract Three, and a 32.5 acre Tract Four conveyed by Gilbert W. Marburger and wife, Hattie C. Marburger, to Janice Doehring, Pauline Klekar, Shirley Ryza, Delora Wagner, Gilbert T. Marburger and Connie Holder by deed dated March 14, 1988, recorded in Volume 767, Page 310 of the Fayette County Deed Records, SAVE AND EXCEPT that 50.00 acres conveyed by Janice Doehring, et al, to Donald E. Schmidt, et ux, by deed dated May 13, 1999, recorded in Volume 1063, Page 149 of the Fayette County Official Records. The above described property was partitioned into 6 tracts of 13.216 acres each. This road easement connects those partitioned tracts, not having public road frontage, to a public road. The centerline of this road easement is more particularly described as follows:

BEGINNING at a 5/8" iron rod set in the north line of a public road, known as Maynard Hallmark Road, marking the southeast corner of that 13.216 acre Tract 5 surveyed this same day for Delora Wagner, the same being the southwest corner of that 13.216 acre Tract 6 surveyed this same day for Gilbert Marburger. This beginning point is located North 88 deg. 52 min. 33 sec. East 274.42 feet from a 3/8" iron rod found in said road line, marking the southeast corner of the said Donald E. Schmidt 50.00 acres;

THENCE North 16 deg. 55 min. 09 sec. East, at 71.04 feet pass a 5/8" iron rod set for the northwest corner of the said 13.216 acre Tract 6, the same being the southwest corner of that 13.216 acre Tract 4 surveyed this same day for Pauline Klekar, for a total distance of 1051.71 feet to a 5/8" iron rod set for an angle in the east line of the said 13.216 acre Tract 5 and the west line of the said 13.216 acre Tract 4;

THENCE North 05 deg. 19 min. 09 sec. East 268.20 feet to a 5/8" iron rod set for the northeast corner of the said 13.216 acre Tract 5 and the southeast corner of that 13.216 acre Tract 2 surveyed this same day for Shirley Ryza, the same being an angle in the west line of the said 13.216 acre Tract 4;

THENCE North 10 deg. 43 min. 09 sec. East, at 99.44 feet pass a 5/8" iron rod set for the northwest corner of the said 13.216 acre Tract 4 and the southwest corner of that 13.216 acre Tract 3 surveyed this same day for Janice Doehring, for a total distance of 916.33 feet to a 5/8" iron rod set for the northeast corner of the said 13.216 acre Tract 2 and the northwest corner of the said 13.216 acre Tract 3, the same being located in the south line of that 13.216 acre Tract 1 surveyed this same day for Connie Manly. This iron rod is marking the TERMINUS of this easement centerline being described.

The foregoing fieldnotes and the attached plat describing the easement centerline were prepared from measurements made on the ground under my direction March 19, 2012.
