ALL TIMBER AND TREES OF EVERY KIND AND SPECIES, AND ALL BIOMASS, WHETHER STANDING, FALLEN OR LYING ON A PORTION OF THE FOLLOWING TRACTS AS SHOWN MORE FULLY ON THE "SALE AREA MAP" ATTACHED HERETO AS EXHIBIT "A", CONTAINING APPROXIMATELY 66 ACRES:

TRACT NO. 1: All that certain tract or parcel of land lying and being in the 1286th G. M. District of Screven County, Georgia, containing 57.0 acres, more or less, and bounded now or formerly as follows: On the North by lands of L. C. Skinner; on the East by lands of John A. Griner Estate (public road being the line); on the South by lands of Cardell Griner; on the West by lands now or formerly belonging to D. E. Jenkins. This being the Southern portion of a the J. R. Griner home place as shown by plat recorded in Deed Book 59, at page 410, of Screven County Records, and is all of said tract except 102.0 acres previously sold to L. C. Skinner according to plat recorded in Book 51, at Page 579, Screven County Records.

TRACT NO. 2: All that certain tract or parcel of land situate, lying and being in the 1286th G. M. District of Screven County, Georgia, containing 102.9 acres, more or less, and bounded now or formerly as follows: On the Northeast by Habersham public road; on the Southeast by lands of Mrs. Susan F. Griner Home Place; on the Southwest by lands of G. T. Jenkins and lands of D. T. Jenkins; and on the West by lands of G. T. Jenkins. For more complete and accurate description of the lands herein conveyed, reference is expressly made to a plat of survey by W. T. Johnson, Surveyor, dated October 10, 1941, and recorded in Deed Book 51, at page 579, Screven County Records.

The Johnson plat is express incorporated herein for more particular description of Tracts 1 and 2 above. Being the same lands conveyed to John B. Bennett under deed from John B. Bennett and Son, Inc. dated June 29, 1990, and recorded in Deed Book 206, page 633, Screven County, Georgia Records.




