Lee County, Illinois Farmland Auction

Lee County, Illinois Farmland Auction! Offering 323.65 acres m/l of high-quality farmland located near Paw Paw and available in four tracts. The auction will take place at 10:00 AM on Tuesday, December 12, 2023, at the Paw Paw Community Center. These farms are situated in a strong farming area with excellent investment potential. US Interstate 39 is nearby, creating multiple grain marketing outlets. Nearby transmission lines and substations have the potential to create added value through wind or solar projects. The farm lease has been terminated and the land will be open to farm for the 2024 cropping season.

Tract 1: 85.4 acres m/l with 79.97 estimated tillable acres carrying an average PI of 125.6 and road frontage along Johnson Road and Lake Road.

Tract 2: 69.0 acres m/l with 67.55 FSA cropland acres carrying an average Pl of 134.2 and road frontage along Johnson Road.

Tract 3: 90.0 acres m/l with 82.69 estimated tillable acres carrying an average PI of 129.1 and road frontage along Earlville Road.

Tract 4: 79.25 acres m/l with 72.63 estimated tillable acres carrying an average PI of 127.7 and road frontage along Earlville Road.

The farmland will be offered as four individual tracts via the "Buyer's Choice" auction method through a live in-person sale. Online bidding will be available as well. With the "Buyers Choice" auction method the high bidder can take, in any order, any or all tracts for their high bid. "Buyer's Choice" auctioning will continue until all four tracts have been purchased and removed from the auction. The tracts will not be offered in their entirety or any combination after the auction. Tracts 1 and 2 are situated north of Paw Paw in Sections 26 and 35 of Willow Creek Township. Tracts 3 & 4 are located south of Paw Paw in Section 22 of Wyoming Township.

Directions

Tracts 1 & 2: From Paw Paw: Travel north on Paw Paw Road for 2 miles to curve. Turn east off of the curve on Howlett Road and travel east for 1/2 mile to Johnson Road. Head north on Johnson Road for 3/4 mile. Tract 1 will be on the west side of the road and Tract 2 will be on the east side of the road.

Tracts 3 & 4: From Paw Paw: Travel south on Paw Paw Road for 1/2 mile to the T and continue along S Paw Paw Road for 450 ft to Earlville Road. Travel south for 1/2 mile and Tract 3 will be located on the west side of the road. Continue south along Earlville Road and Tract 4 will be located on the west side of the road.











Tract 1 consists of 85.4 acres m/l with 79.97 acres m/l currently tillable and an average Productivity Index of 125.6. This tract is considered Non-Highly Erodible Land (NHEL) with the main soil types being productive Fayette silt loam and Elpaso silty clay loam. Recent tile has been added to remediate a small wet spot that was previously found along the eastern edge of the property. Trees were removed in the far southeast corner within the past few years making this a turn-key farm ready to produce excellent crops. The land has road frontage along Johnson Road and Lake Road and is located in Sections 26 and 35 of Willow Creek Township, Lee County, Illinois.

Tract 2 consists of 69.0 acres m/l with 67.55 acres m/l currently tillable and an average Productivity Index of 134.2. This tract is considered Non-Highly Erodible Land (NHEL) with the main soil types being productive Greenbush, Saybrook, and Muscatune silt loams. Recent tile has been added to remediate a small wet spot that was previously found in the northwest corner of the property. This farmland lays excellent with a high percentage of tillable acres and no significant waterways or ditches. The land has road frontage along Johnson Road and is located in Sections 26 and 35 of Willow Creek Township, Lee County, Illinois.
