## DECLARATION OF RESTRICTIVE COVENANTS PERMAINING TO FORDUSH FOREEN DEVILOPEENT LOCATED IN LIDERTY TORNSHIP, YADKUN COUNT

Book 182

Know all men by these presents that Clyde Dinkins and wife, Hyrtle W. Dinkins, and Lillian T. Pendry, (Widow), do hereby covenant and agree to and with all persons, firms and corporations hereafter acquiring lots in the development known as Forbush Forest Development, a plat of which will be recorded in the Office of the Register of Deeds of Yadkin County; that all such lots are hereby subjected to the following restrictions as to the use thereof, the said restrictions being appurtement to and running with the said land by whosever owned, except all lands of Forbush Forest D velopment lying Vest of the Styers Hill, Road, including the proposed changes.

1. All of the lots and tracts in Forbush Forest Development shall be used for residential purposes only.

2. No residence shall be erected on any of said lots of less than 1400 square feet of floor space, excluding porches, garages and carports.

3. No residence shall be crected near the front property line (Street line) less than 60 feet nor near either side line property line than 25 feet, provided, however, this particular provision shall not apply to garages and outbuildings crected in the rear of said residences, unless written permission is given by grantors herein.

4. No residence shall be erected on a lot containing less than ONE acre.

5. No exterior foundations above ground level shall not leave exposed concrete or cinder building blocks.

6. No swine shall be kept on the premises and no enclosures for swine shall be erected and maintained on the land.

7. No outside toilets shall be erected or permitted on this property.

8. No structure of a temporary character, trailer, mobile home, basement, tent, shack, garage, bar or other outbuildings shall be used on any lot at any time as a residence, either temporarily or permanent.

9. No animals, livestock, or poultry of any kind shall be reised; bred, or kept on any lot for commercial purposes.

10. No Steets or Driveways shall be cut through the above described property without the written consent of grantors herein.

11. Any person who shall fail to fully comply with all restrictions stated herein shall be liable for all Court costs and attorney fees expended in the enforcement of these restricted covenants.

These covenants are to run with the land and shall be binding on all parties and all persons claiming under them.
