

Legal Description

A Tract of Land in the John W. Crunk Survey, Abstract Number 160, Wise County, Texas, and being "First Tract", and "Second Tract" as described in a deed to Mary Rutherford Stephens (a widow) recorded in Volume 367, Page 866, Deed Records, Wise County, Texas; Together With a tract of land described in a deed to Mary Stephens, recorded in Volume Volume 709, Page 98, Deed Records, Wise County, Texas, and being described as one (1) tract by metes and bounds as follows:

Beginning at an 8" wood fence post for the most northerly corner of First Tract, said point having NAD 83, Zone 4202 (Grid) coordinate value of North = 7,187,698.54 feet, and East = 2,279,800.30 feet, for reference;

Thence the following courses and distances along the northeasterly line of First Tract:

South 44° 53' 29" East a distance of 879.61 feet to a railroad tie fence post;

South 45° 16' 34" West a distance of 125.42 feet to a railroad tie fence post;

South 17° 57' 00" East a distance of 352.11 feet to the most easterly northeast corner of First Tract;

Thence South 43° 31' 52" West a distance of 123.24 feet along the southeasterly line of First Tract to 6" wood fence post for the most northerly corner of said Mary Stephens tract recorded in Volume Volume 709, Page 98;

Thence the following courses and distances along the northeasterly line of said Mary Stephens tract:

South 45° 53' 22" East a distance of 502.53 feet to a 8" wood fence post;

South 42° 55' 02" West a distance of 247.60 feet to a 1/2" iron rod set with cap stamped, "BARRON STARK";

South 49° 58' 08" East a distance of 310.15 feet to a 1/2" iron rod set with cap stamped, "BARRON STARK":

South 44° 40' 51" West a distance of 324.33 feet to a 1/2" iron rod found;

South 12° 13' 36" East a distance of 207.56 feet to a 1/2" iron rod found;

South 45° 37' 51" East a distance of 190.83 feet to the most southerly southeast corner of said Mary Stephens tract, in the northwesterly line of F.M. Highway 1204;

Thence the following courses and distances along the northwesterly line of F.M. Highway 1204:

South 41° 57' 06" West a distance of 31.66 feet;

North 48° 02' 58" West a distance of 5.00 feet to the beginning of a curve, concave to the northwest, having a radius of 1,596.71 feet, and a long chord which bears South 47° 19' 13" West a distance of 306.13 feet;

Southwesterly along said curve a distance of 306.60 feet;

South 52° 57' 06" West a distance of 71.56 feet to the most southerly corner of said Mary Stephens tract and to the most easterly corner of said Second Tract;

South 47° 36' 49" West a distance of 405.64 feet to a 6" metal fence post for the most southerly corner of said Second Tract:

Thence North 41° 13' 45" West a distance of 1,154.06 feet to a 3" metal fence post for the most westerly corner of said Second Tract, in the southeasterly line of First Tract;

Thence South 45° 15' 54" West a distance of 4,474.49 feet, generally along a fence, to a 7" wood fence post for the most southerly corner of First Tract;

Thence North 45° 08' 57" West a distance of 1,223.56 feet to a 2" metal fence post for the most westerly corner of First Tract;
